1	MR. KRULL: Good morning. I'm Matthew
2	Krull, Health Policy Counsel, at the Department
3	of Community Health in the Office of General
4	Counsel. Today is July 13th, 2020. It is now
5	9:00 10:00 a.m.
6	This is the public hearing on Georgia's
7	Reinsurance and the Georgia Access Section 1332
8	State Relief and Empowerment Waiver. This
9	public hearing is being held in person and
10	virtually through the Webex videoconferencing
11	system.
12	This public notice was issued by Governor
13	Brian B. Kemp on July 9, 2020. This notice is
14	incorporated into these proceedings.
15	Pursuant to 31 C.F.R. Section 33.112 and 45
16	C.F.R. Section 155.1312, the State of Georgia is
17	providing public notice and a comment period
18	prior to submitting a modification to its
19	previous Section 1332 waiver application
20	submitted to the departments of Health and Human
21	Services and the Treasury on December 23rd,
22	2019. On July 9th, 2020, the Governor issued a
23	press release opening a second comment period
24	for an additional 15 days to allow for a
25	thorough public comment.

1	The public comment period will expire on
2	July 23rd, 2020 at 11:59 p.m. Individuals
3	wishing to provide written comments on or before
4	July 23rd, 2020 may submit comments online
5	through a web form, which can be found at
6	medicaid.georgia.gov/patientsfirst, or by mail
7	to Ryan Loke, care of The Office of the Governor
8	at the following address: 206 Washington
9	Street, Suite 115, State Capitol, Atlanta,
10	Georgia 30334. Comment letters must be
11	postmarked by July 23rd, 2020 to be accepted.
12	At the conclusion of the comment period, all
13	oral comments presented today will be
14	transcribed and included in the final waiver
15	application.
16	If you are present in the hearing room
17	today and wish to make oral comments, please
18	sign in on the appropriate roster. To ensure
19	the health and safety of all Georgia residents
20	and comply with Governor Kemp's Executive Order
21	06.29-20-02, we are limiting the number of
22	in-room attendees at this hearing to no more
23	than 50. Please maintain a social distance of
24	at least 6 feet between each other. You are
25	also strongly encouraged to wear a mask or face

1 covering while you are in the building. 2 For those of you that are participating virtually through Webex and wish to make an oral 3 comment, please click the "raise hand" button at 4 5 the bottom right of the participant panel on your browser window. The button looks like a 6 7 hand. If the participant panel is not visible, 8 please click the third button from the left on 9 the bottom menu bar on the Webex browser window. Clicking this button will open the participant 10 11 panel on the right-hand side of the Webex 12 browser window where you will find the "raise 13 hand" button. Once you click the "raise hand" button, a 14 15 hand image will appear next to your name in the participant panel. This notifies the moderator 16 17 that you wish to make an oral comment today. Oral comments will first be received by 18 19 individuals attending in person, after which the 20 online monitor will call on members of the public who raised their virtual hand on the 21 22 Webex participant panel in order to provide oral 23 comments. 1	At this time, I'd like to introduce
2	Mr. Blake Fulenwider, Chief Health Policy
3	Officer at the Department of Community Health,
4	to provide a short overview of the modified 1332
5	waiver application prior to accepting public
6	comments.
7	MR. FULENWIDER: Thank you very much, Matt.
8	Good morning, ladies and gentlemen. I'm
9	Blake Fulenwider with the Department of
10	Community Health. And today I'm going to if
11	you'll advance to the next slide, please. Today
12	I'm going to provide a brief overview on the
13	background and modifications to the Georgia
14	Access 1332 waiver application.
15	As Mr. Krull stated, we will then open for
16	in-person public comments should we have any
17	attendees wishing to make comment. We'll then
18	open the floor for Webex participant public
19	comment. And also would like to remind the
20	public that they are able to submit comments
21	online or through regular mail through
22	July 23rd, 2020 online at
23	medicaid.georgia.gov/patientsfirst, or via mail
24	to Ryan Loke, care of The Office of the
25	Governor, 206 Washington Street, Suite 115,

1 State Capitol, Atlanta, Georgia 30034. 2 Now to provide background information. As you know, this is part of Senate Bill 106 or the 3 Patients First Act that was signed into law by 4 5 Governor Brian Kemp on March 27th, 2019, which grants the Governor the authority to submit one 6 7 or more Section 1332 innovation waivers to the 8 departments of Health and Human Services and 9 Treasury. The 1332 waivers must be submitted on or 10 11 before December 31st, 2021. And upon approval 12 of one or more 1332 waivers, the Patients First 13 Act authorizes the state to implement the waivers without further legislative action. 14 1332 waivers are designed to pursue 15 innovative strategies that promote access to 16 17 high quality and affordable health insurance by meeting four statutory guardrails set out under 18 19 the Affordable Care Act. The waivers must be as 20 comprehensive as coverage available absent the waiver. It must be at least as affordable as 21 absent the waiver. Coverage must provide 22 23 coverage to a comparable number of residents 24 absent the waiver. And, also, must not increase the federal deficit. 25

1	Initially through this process that started
2	in June 2019, we and our consulting partners
3	completed a state and national environmental
4	scan to identify our priorities, developed a
5	model of potential waiver options, drafted and
6	submitted an initial waiver application both via
7	1332 and 1115 which were released for public
8	comment on November 4th, 2019. And both were
9	formally submitted to the Department of Health
10	and Human Services and Treasury on
11	December 23rd, 2019.
12	Today we are holding our first of two
13	public hearings on a modified 1332 Georgia
14	Access waiver application that was posted on
15	July 9th, 2020. This is to reflect
16	modifications to the waiver based on recent
17	changes in the state and national landscape.
18	Again, public comment will remain open through
19	July 23rd, 2020.
20	Goals of the Georgia Access 1332 waiver
21	include reducing premiums, particularly in
22	high-cost regions; incentivizing carriers to
23	offer plans in more regions across the state;
24	foster innovation to provide better access to
25	services; expand choice and affordability for

1	consumers; attract uninsured Georgians into the
2	insurance market; maintain access to metal level
3	qualified health plans and catastrophic plans;
4	and maintain protections for individuals with
5	preexisting conditions.
6	Part one of the Georgia Access 1332 waiver
7	include establishment of a reinsurance program
8	to stabilize individual market premiums and
9	attract and retain carriers in regions across
10	the state. Part two seeks to transition away
11	from healthcare.gov to the Georgia Access model
12	which will improve access, choice, and
13	affordability for consumers.
14	One modification included in the modified
15	1332 application include a delay of
16	implementation of part one to January 1st, 2022.
17	Part one was originally slated to begin on
18	January 1st, 2021. Both part one and part two
19	will concurrently begin January 1st, 2022.
20	As noted, the reinsurance program has been
21	shifted to plan year 2022. Additionally, the
22	state is not seeking authority to certify and
23	offer subsidies for eligible nonqualified health
24	plans. We are not seeking authority to issue
25	state subsidies. Subsidies for the federal

1	advanced premium tax credits and premium tax
2	credits would be administered by the Department
3	of the Treasury, Internal Revenue Service, with
4	enrollment and subsidy eligibility information
5	being provided by the bid state.
6	The reinsurance program under part one
7	still maintains a claims-based reinsurance model
8	beginning in 2022. It establishes an attachment
9	point of \$20,000, with a cap of \$500,000, and a
10	three-tiered coinsurance rate of 15, 45 percent,
11	and 80 percent, depending upon region. Higher
12	coinsurance rates are applied to higher-cost
13	regions of the state. In total, the waiver
14	seeks to target a 10 percent reduction in
15	average premiums statewide.
16	For front-end operations, we will rely on
17	the private sector or web-brokers or carriers to
18	provide the experience for consumers to shop,
19	compare, and purchase plans. They would
20	leverage mechanisms and incentives in the
21	commercial market to provide education,
22	outreach, and customer service.
23	Back-end operations managed by the state
24	include calculation of federal subsidy
25	eligibility and transmission of that information

1	to the treasury department. Back-end operations
2	handled at the federal level include issuance of
3	advanced premium tax credits for qualified
4	health plans to the plans on behalf of
5	individuals and reconciliation of premium tax
6	credits for an individual during tax filing.
7	The benefits of the modified Georgia Access
8	1332 waiver include maintaining access to
9	current qualified health plans and catastrophic
10	plan options, providing consumers the ability to
11	view all plans available to them which are
12	licensed and in good standing with the state via
13	the Georgia Access web-broker platform, allowing
14	consumers to enroll and reenroll directly with
15	carriers, and providing greater accuracy in
16	projecting consumer subsidy eligibility by
17	leveraging more updated income verification
18	sources available to the state. This waiver
19	also further streamlines referrals to and from
20	Medicaid as individuals may churn into the
21	Medicaid program into Georgia Access and back
22	and forth.
23	At this time, we will begin our public
24	comment period. We will begin by opening for
25	in-person public comments.

1	I note that there are no attendees in
2	person in the boardroom.
3	Any call for anyone seeking to make
4	in-person public comments?
5	MR. KRULL: Just a reminder if you want to
6	make a public comment and you're using the Webex
7	platform, there is a button down at the bottom
8	in the middle if you look at the screen right
9	now. It'll access the participant panel. And
10	once you access the participant panel, there
11	will be a small hand.
12	Move to the next slide, Lavinia. Move it
13	that way so they can see.
14	MR. FULENWIDER: So to clarify, we have
15	opened the floor for Webex comment?
16	MR. KRULL: Absolutely. If you're, if
17	you're attending through Webex, if you want to
18	make a comment, click the small hand at the
19	participant panel. If you look on your screen
20	right now, it'll show you an example of where
21	the hand is. You'll raise your hand. It'll
22	notify us that you want to comment.
23	And I'll give everyone a few minutes to
24	digest what Blake has gone through and determine
25	if anyone wants to make a comment. If you are

1	going to make a comment, we're going to limit
2	your comments to five minutes today. And please
3	keep your comments limited to the issues that
4	directly relate to the proposed public notice.
5	At the end of your five minutes, if you have not
6	completed your presentation, I may ask for a
7	brief closing statement. And you'll also be
8	able to submit any remaining comments in
9	writing.
10	We'll give it, we'll give it a couple more
11	minutes.
12	So if you if you're attending the public
13	hearing through Webex and you want to make a
14	public comment today, if you would click on the
15	"raise hand" button at the bottom of the
16	participant panel on the right-hand side. If
17	you look at the screen right now, there's an
18	example where the button is. Click on that. It
19	will notify us if you want to make a public
20	comment.
21	We're going to give you all a couple more
22	minutes to make a decision whether you want to
23	comment. And a reminder is there is another
24	public hearing on July 22nd that will also be in
25	person here at 2 Peachtree, and also virtually

1	through Webex.
2	We'd like to thank each of you for
3	attending the virtual public hearing and the
4	in-person public hearing today. No one has
5	indicated that they wish to make oral comments
6	at this time. I reiterate that the public
7	comment period for the modified application
8	the changes to the modified application will
9	expire on July the 23rd, 2020.
10	As indicated earlier, written comments will
11	be entered into the official record as well as
12	the transcript of this hearing today.
13	Thank you once again for the hearing.
14	There being no further person who wish to make a
15	comment, this public hearing is adjourned at
16	10:20 a.m.
