The Medicaid Care Management Organizations Act (the "Act") requires the Care Management Organizations (CMOs) to provide a Hospital Statistical and Reimbursement (HS&R) report within 30 (thirty) days upon request of a provider. Specifically, O.C.G.A. 33-21A-11 states:

Upon request by a hospital provider related to a specific fiscal year, a care management organization shall, within 30 days of the request, provide that hospital with an HS&R report for the requested fiscal year. Any care management organization which violates this Code section by not providing the requested report within 30 days shall be subject to a penalty of \$1,000.00 per day, starting on the thirty-first day after the request and continuing until the report is provided. It is the intent of the General Assembly that such penalty be collected by the Department of Community Health and deposited into the Indigent Care Trust Fund created pursuant to Code Section 31-8-152. A care management organization shall not reduce the funding available for health care services for members as a result of payment of such penalties.

Additionally, the CMOs must submit a list of the requested HS&R reports to the Department of Community Health ("the Department" or DCH) no later than thirty days following the calendar quarter period.



As requested by the Department, Myers and Stauffer LC (Myers and Stauffer) tested the information included on the quarterly HS&R reports submitted by the CMOs in response to the Act for the quarter beginning January 1, 2018 and ending March 31, 2018 ("Quarter 1"). We attempted to confirm the information reported by the CMOs to demonstrate their compliance with the HS&R reporting requirements of the Act.

The quarterly HS&R reports submitted to the Department by the CMOs contain the following data: the identification of hospitals that requested HS&R reports including location, name of report requestor, date the HS&R report(s) were requested, the date the CMO released the report to the hospital or requestor, and other related information.

Using the HS&R reports provided by each CMO, we attempted to confirm no less than five report requests for each respective CMO. The Methodology section provides an overview of how we analyzed the data on the quarterly reports.



In order to perform this analysis, we utilized the quarterly reports submitted to DCH by each of the CMOs. Amerigroup Community Care (AGP), CareSource (CS), Peach State Health Plan (PSHP), and WellCare of Georgia (WellCare) reports were obtained by accessing their web portals on May 10, 2018. For Quarter 1, 134 HS&R reports were reported by the CMOs and can be found in Exhibit A of this report.

In accordance with the confirmation process approved by DCH, Myers and Stauffer requests confirmation of the CMO-reported request and release dates from providers, or their representatives, when the CMO-reported release date is 30 days or greater from the CMO-reported request date. With DCH's approval, HS&R reports were randomly selected for Amerigroup, CareSource, Peach State Health Plan, and WellCare to contact providers for confirmation of the dates reported by the CMOs.

Telephone calls or e-mails regarding 64 HS&R reports were initiated on May 11, 2018 and completed on July 3, 2018. Providers were asked to provide the date they requested the HS&R report and the date the CMO provided notification that the report was available.

A maximum of three attempts per provider were performed in an effort to acquire data for this analysis.

Once the data was collected, we analyzed the results and performed follow-up communication as necessary. Provider responses were compared with the dates reported on each CMO's quarterly report.

ASSUMPTIONS AND LIMITATIONS

The assumptions and limitations summarized below should be noted when reviewing this report.

- Our procedures were not designed to identify instances where a CMO may have failed to include a provider's request for an HS&R report in the CMO's report to DCH. However, had instances occurred where a provider stated they requested an HS&R report from a CMO that was not included in the CMO's report to DCH, Myers and Stauffer would have communicated with the respective CMO to confirm the information obtained from the provider.
- Myers and Stauffer accepted a verbal or an email confirmation for information received from providers.
- If there was a disagreement between the CMO and provider, Myers and Stauffer accepted the documentation submitted by the CMO as confirmation.
- If instances occurred where a provider stated they received a requested HS&R report from a CMO after 20 days and that report was originally excluded from our confirmation process, we would have communicated with the respective CMO to confirm the information obtained from the provider.
- As instructed by the Department, if the due date of the report, 30 days after the report was requested, fell on a Saturday or Sunday, the next business day was assumed to be the due date for purposes of this analysis.

This section provides a summary of the analytical findings for this analysis. A summary of findings can be found on pages 8-9 of this report.

As illustrated in the table above, we have included the total number of reports each respective CMO reported to the Department for Quarter 1. The findings indicate for 95.3 percent (61 of 64) of the HS&R reports, the providers were able to confirm the information reported by the CMOs. Providers disagreed with the CMO reported dates for two report requests. Providers were unable to validate the CMO reported dates for one report request.

The statistics included in Table II are based on the dates contained within the CMO quarterly reports. Although the dates given to Myers and Stauffer by the providers were considered in the analysis, documentation provided by the CMOs was used to confirm the dates reported to DCH by the CMOs.

AMERIGROUP

For Quarter 1, Myers and Stauffer did not identify any HS&R reports released by Amerigroup to a provider that were greater than 30 days. Eleven representatives were contacted regarding 16 HS&R report requests. Myers and Stauffer did not identify any HS&R reports released by Amerigroup to a provider that were greater than 20 days. The request and release dates reported by the CMO were confirmed for 16 requests.

CARESOURCE

For Quarter 1, ten representatives were contacted regarding 16 HS&R report requests. Myers and Stauffer identified 16 HS&R reports released by CareSource to a provider that were greater than 20 days. The request and release dates reported by the CMO were confirmed for all report requests. We found 13 HS&R reports where the release date was greater than 30 days. We requested clarification regarding the late HS&R reports from CareSource. Erika Lawrence, a CareSource representative, responded with the following:

"CareSource's ability to provide timely Hospital Statistical and Reimbursement Reports requested during Q1 2018 was adversely impacted by a delay in receiving the HS&R technical specifications from the Department and system configuration of the report. The first produced HS&Rs were completed 4/11/2018. All HS&R requests received following 4/11/2018 have been completed and provided to the requesting facilities within the required 30 days from the date of the request."

We were then provided a response from DCH regarding CareSource's explanation. Sandra Middlebrooks, a DCH representative, responded with the following:

"According to CareSource, they would have had the configuration of the HS&R report completed by Feb. 26, 2018. Could you recalculate from this date and submit a new report? Thanks."

Myers and Stauffer updated revised the CMO release date to and adjusted the potential penalty. A revised report can be found in Exhibit B of this report.

PEACH STATE HEALTH PLAN

For Quarter 1, Myers and Stauffer did not identify any HS&R reports released by Peach State Health Plan to a provider that were greater than 30 days. Eleven representatives were contacted regarding 16 HS&R report requests. Myers and Stauffer identified nine HS&R reports released by Peach State Health Plan to a provider that were greater than 20 days. The request and release dates reported by the CMO were confirmed for 16 requests.

WELLCARE

For Quarter 1, eight representatives were contacted regarding 16 HS&R report requests. Myers and Stauffer identified 16 HS&R reports release by WellCare to providers that were greater than 20 days. The request and release dates reported by the CMO were confirmed for 15 requests. We were unable to confirm one report request as one provider was deemed unreachable after contact was initiated three times.



Myers and Stauffer identified one HS&R report released by WellCare to a provider that was greater than 30 days, see Exhibit C. We requested clarification regarding the late HS&R report from WellCare. Heather DiNapoli, a WellCare representative, responded with the following:

"The dates are correct on the attached. Please let me know if you have further questions."

In addition, the Quarter 1 HS&R Report submitted to DCH was missing a release date from Smith Northview Hospital. We contacted WellCare regarding the missing request. Heather responded with the following:

"The dates that the requestor wanted did not have claims data; therefore, the reports could not be generated."

SUMMARY OF POTENTIAL PENALTIES

Based on the findings for CareSource and WellCare, there are potential penalties for late reporting that DCH may elect to assess for the quarter beginning January 1st, 2018 and ending March 31st, 2018 ("Quarter 1").

CareSource was 249 days late and WellCare was 79 days late providing the requested HS&R reports. Georgia statute (O.C.G.A. 33-21A-11) states, "...Any care management organization which violates this Code section by not providing the requested report within 30 days shall be subject to a penalty of \$1,000.00 per day, starting on the thirty first day after the request and continuing until the report is provided."

Pursuant to the statutory and contractual requirements, DCH may elect to impose penalties of up to \$79,000 on WellCare and \$249,000 on CareSource.

RECOMMENDATIONS

We make the following recommendations to the Department based on our findings after analyzing the Quarter 1, 2018 HS&R reports:

- The Department may wish to assess a penalty of \$249,000 against CareSource for the thirteen HS&R reports which were not released within 30 days.
- The Department may wish to assess a penalty of \$79,000 against WellCare for the HS&R reports which were not released within 30 days.
