



Electronic Visit Verification

Third-Party EVV Vendors

To be compliant with Section 1903(I) of the Social Security Act, as added by section 12006 of the 21st Century Cures Act (Pub. L. No.114-255) and further amended by Public Law No. 115-222, the State of Georgia implemented Electronic Visit Verification (EVV) for Personal Care Services (PCS) on April 1, 2021, and is working to determine the best path forward to expand the functionality to support EVV for Home Health Care Services (HHCS) in the future. The requirements of Section 1903(I) apply to PCS and HHCS provided through Georgia's Home and Community Based Services (HCBS) programs under the following authorities:

- SSA Section 1915(c) Home and Community-Based Services Waivers
- State Plan for Georgia Pediatric Program In-Home Nursing

The Department of Community Health (DCH) has implemented a State EVV solution that can be used by Providers to meet state and federal EVV requirements. Providers have the option to select an alternative third-party EVV solution that is currently integrated with the State EVV solution.
