PeachCare for Kids®

Overview

Congress created Title XXI of the Social Security Act in 1997 to provide health care for the growing number of uninsured children in the United States. This legislation enabled states to create State Children's Health Insurance (SCHIP) programs to increase access to affordable health insurance. In Georgia, this program is PeachCare for Kids.

PeachCare for Kids began covering children in 1998 and provides comprehensive coverage to uninsured children. S-CHIP was reauthorized in 2009, as part of the Children's Health Insurance Program Reauthorization Act (CHIPRA).

Program Description

PeachCare for Kids is a medical assistance program that provides health care coverage for uninsured children living in Georgia. The health benefits include primary, preventive, specialist, dental and vision care. Children that are covered by other major medical insurance are not eligible for PeachCare for Kids.

Eligibility Determination

Eligibility for PeachCare for Kids is evaluated as part of an overall medical assistance determination of the most beneficial coverage for a child based on income and household circumstances. To ensure appropriate enrollment in the program, PeachCare for Kids requires citizenship and income be verified for all new applicants. Children in a family with income at or below 247 percent of the <u>federal poverty level</u> may qualify.

Income is verified annually as part of the renewal process. The documents required for verification are available on our <u>documents</u> <u>verification page</u>. Children's families whose income falls within the Medicaid limits are not eligible for PeachCare for Kids and will automatically be enrolled in the appropriate Medicaid program. Should income increase to within the PeachCare for Kids income limits, children will be placed on PeachCare for Kids without the need for a new application.





Eligibility

- U.S. citizens and qualified immigrants
- Georgia residents
- Age 18 and under (eligible until 19th birthday)
- Family income less than or equal to 247 percent of federal poverty level

Premiums

There is no cost for children ages 5 and under, children in foster care, or children who are American Indians or

Alaska Natives. For all other children between the ages of 6 and 18, the monthly premiums for PeachCare for Kids coverage range from \$11 to \$36 for one child and \$16 to \$72 for two or more children living in the same household, depending on the household income. There are no deductibles required for benefits covered by the program.

Co-Pays

A co-payment is a small fee paid by the member/parent at the time of the visit to a medical provider. The amount of the co-payment will be different depending on the medical service(s) received. While these co-payment amounts can range from \$0.50 to \$12.50, most will be \$2 or \$3. If a co-payment is required, the medical provider will tell the member/parent at the time of the visit.

For children ages 6 or older, a co-payment is required for some medical services in the PeachCare for Kids program. A co-payment may not be required for all children between the ages of 6 through 18. The following are exempt from co-payments:

- Members under age 6
- Well-baby and well-childcare services
- Children with income less than 150% federal poverty level
- Members in end-of-life care
- Nursing facility residents
- Children in foster care
- American Indian or Alaska Natives
- Pregnant and post-partum enrollees are not charged co-payments but are subject to premiums

However, there are **no co-payments** for these services:

- Emergency services
- Preventive Care Services (routine check-ups for your child)
- Immunizations
- Routine preventive and diagnostic dental services (such as oral examinations, prophylaxis and topical fluoride applications, sealants, and X-rays)

Parents with children on PeachCare for Kids are not required to pay more than 5 percent of their yearly income for premiums and co-payments. If the family reaches the 5 percent limit, the member will not be required to make co-payment and premium payments for the rest of the year. Therefore, it is important that the parent report any changes to family income.

There are no premiums or co-payments charged for children that are under six years old, children in foster care, American Indians and Alaskan Natives (AI/AN).

Citizenship Requirements

As with all medical assistance programs, to be eligible for PeachCare for Kids, children must be citizens of the U.S. or qualified immigrants and, in many cases, must have resided legally in the U.S. for at least five years. *NOTE: Citizenship and qualified immigrant status applies ONLY to the child. Eligibility for PeachCare for Kids is*

not based on the citizenship or immigration status of the parent(s).

Applying to PeachCare for Kids

PeachCare for Kids is part of the medical assistance application online at <u>www.gateway.ga.gov</u>. When you apply, children who fall under the Medicaid limits will be put on the appropriate type of Medicaid. Children who fall within the PeachCare for Kids limits will be put on Peachcare for Kids. No separate application is needed.

Benefits of PeachCare for Kids

- Preventive services such as immunizations and regular check-ups
- Care from your doctor when your child is sick
- Specialist care
- Dental care
- Vision care, including vision screenings and eyeglasses
- Hospitalization
- Emergency Room services
- Prescription medications
- Mental health care
- Membership in a Care Management Organization (CMO) that coordinates the child's care

PeachCare for Kids Funding

PeachCare for Kids funding is provided by the state of Georgia, the federal government (Title XXI funds), and premiums collected for children ages 6 through 18. Under the provisions of Title XXI, federal matching funds are available to subsidize more than 75 percent of the benefit cost less premiums, with the remaining percentage coming from the state. The percentage of federal matching funds is adjusted annually.

PeachCare for Kids is not an entitlement program. It is subject to the availability of funds specifically appropriated for this program. DCH's Division of Medical Assistance Plans is authorized to institute utilization control procedures, limit enrollment, or modify health benefits to stay within available funding.

Future of PeachCare for Kids

CHIPRA, which reauthorized children's health insurance programs across the country, will provide funding for PeachCare for Kids through 2029.
