OVERVIEW

The state of Georgia is now entering into the second year of our family planning demonstration, called Planning for Healthy Babies (P4HB), which expanded eligibility for family planning and related services to newly qualified women ages 18 through 44 years if they meet income and other eligibility requirements. The P4HB program also provides eligible women delivering a very low birth weight baby with access to inter-pregnancy care services, comprised of limited primary care, dental, mental health and case management services aimed at keeping them and their very low birth weight babies healthy and increasing their inter-partum intervals. The demonstration began January 1, 2011 and is scheduled to end December 31, 2013. This report provides information on several aspects of P4HB for the first quarter of the demonstration's second year of operation, which began on January 1, 2012.

We will present data on the progress that has been made, such as: increasing awareness of the program; increased calls regarding eligibility; and significant increases in the number of women enrolled in the family planning only component of the demonstration. We also report on a new, auto-enrollment initiative that began during the last quarter of 2011. Auto enrollment allows Medicaid eligible women who recently gave birth or young women aging out of the Peach Care for Kids® program (Georgia's stand alone CHIP program) to be automatically enrolled in the P4HB program. Also included in this report are the required data elements of the Section 1115 Demonstration as noted below:


- Total number of enrollees;
- Updated budget neutrality worksheet;
- Events occurring during the quarter, or anticipated to occur in the near future that
 affect health care delivery, benefits, enrollment, grievances, quality of care, access,
 pertinent legislative activity, eligibility, verification activities and other operational
 issues
- Action plans for addressing any policy and administrative issues identified; and
- Evaluation activities and interim findings.

ELIGIBILITY, ENROLLMENT, and DISENROLLMENTS

Throughout the first year of the demonstration, there was significant growth in: the number of women requesting information about the P4HB program; the number of women actually applying for benefits; and the number of women eventually enrolled in the demonstration and receiving services within a CMO. This growth has continued into the first quarter of 2012, benefiting greatly from the auto-enrollment process discussed later in this report.

Policy Studies Institute (PSI) manages the call center for the P4HB program and provides weekly reports pertaining to the volume of calls received for the program. The number of total unique calls during each month continues its upward trend as shown in the graph below.





The call volume in the first quarter increased 16% from the 2,905 calls observed during the month of December 2011 to the 3,357 calls observed by the end of March 2012. It is likely that this latest increase in call volume correlates with the mailing of letters in the latter part of 2011 as part of the auto-enrollment process. The average talk time for each woman calling into the call center continues to be about five minutes.

The increasing interest in P4HB, exhibited by the call volume, is also showing up in increased numbers of women applying and being determined eligible. By the end of this first quarter of 2012, 32,851 women had been determined to be eligible for Planning for Healthy Babies. Of these, 32,824 were deemed eligible for family planning only (FP) benefits and 27 were deemed eligible for the inter-pregnancy care (IPC) benefits within P4HB. This represents nearly a 58% increase over the number of women deemed eligible by the end of the fourth quarter of 2011 (20,815). For this first quarter of 2012, the great majority (96%) of the women deemed eligible were under age thirty-six and more than two-thirds of the eligible women (72%) were in the youngest age group, 18-22. We noted in our fourth quarter report that the number in the youngest age group had tripled from the third quarter. By the end of this first quarter of 2012, the number of those 18-22 years old deemed eligible had grown by another 61%. Within this group, those aged 19 (the group likely aging out of Peach Care for Kids®) remained a high percentage of the total - 53%.

Even though the overall number of P4HB eligible women has grown markedly, there were only twenty-seven women deemed eligible in the IPC component by the end of the first quarter of 2012. Our program staff members continue to work with our Georgia Families Care Management Organizations (CMOs) and the DCH Communications team to modify our strategies aimed at increasing the number of women enrolled in the IPC component of the program. We will be implementing an auto enrollment process for the IPC component during the next quarter to boost enrollment.

Consistently, our data has shown that a concentration of women deemed eligible for P4HB

family planning benefits reside in the metro-Atlanta counties of Fulton, DeKalb, Gwinnett, Clayton and Cobb. We also note that during the first quarter of implementation of the demonstration in 2011, 86% of the women deemed eligible for the program resided in the metro Atlanta counties. As demonstrated in Table 1, by the end of the first quarter of 2012, the number of women deemed eligible for P4HB and residing in these five counties totaled 10,411 or only 32% of the 2012 first quarter total. Because a significant portion of Georgia's population resides in metro Atlanta, this trend needs further investigation. One positive thought however, is that this decline in percentage for these five metro Atlanta counties indicates that women from other metro and non-metro counties of Georgia are increasingly learning about P4HB and completing applications to join the program.

In December 2011, a process was implemented to auto-enroll women who had delivered babies under the Right from the Start Medicaid (RSM) eligibility criteria into P4HB. These RSM women would automatically be eligible for the family planning component of the waiver. We also began auto enrolling 19 year olds as they 'aged out' of the Peach Care for Kids® program. RSM and Peach Care for Kids® women received a letter in December 2011, informing them about P4HB and their option to 'opt out' of the program. Women choosing to accept this auto enrollment by not opting out of the P4HB program also have the option to stay with their same CMO or they can switch to a different CMO during their annual Medicaid renewal period.

The January through March 2012 statistics indicate the auto-enrollment process expanded knowledge and increased enrollment in the P4HB program. December 2011 was the first month of auto enrollment and enrollment into a CMO grew from 6,433 in November 2011 to 7,566 in December 2011. By January 2012, P4HB enrollment into a CMO had increased to 13,571 and by March 2012. 22,129 women were enrolled with a CMO. Auto-enrollment is now an ongoing component of the P4HB enrollment process and as previously mentioned, work is progressing to allow auto-enrollment into the IPC component for those women who deliver VLBW infants and meet P4HB eligibility requirements. The additional requirement for the IPC component is confirmation that the woman who was auto enrolled gave birth to a very low birth weight infant. The providers or their staff members who are medically knowledgeable about the woman's VLBW birth complete and submit the VLBW confirmation form for the member in order for her to access the benefits of the IPC program. We have also initiated the resolution to a second barrier, namely third party liability (TPL) for vision and dental services, which was impacting the P4HB eligible woman's ability to select a CMO in order to receive P4HB services. Information system modifications have been identified and discussed with our MMIS vendor that will eliminate this TPL interference impacting the P4HB CMO selection process.

As stated above, 22,129 out of 32,851 P4HB eligible women were enrolled in a CMO by the end of this first quarter of 2012. This number indicates that the rate of enrollment among those eligible has nearly doubled from 36% at the end of fourth quarter 2011 to 67.4% at the end of the first quarter 2012. This change most likely reflects the success of the auto-enrollment process. In our earlier reports we discussed that some of the delays between determination of program eligibility and CMO enrollment resulted from the time needed for the woman to either choose her CMO or be auto-assigned. Auto-enrollment has removed this particular barrier to

P4HB enrollment.

In the IPC component of the demonstration, we saw a relatively small increase (32%) in the number of women eligible for IPC services from the fourth quarter 2011 enrollment of 19 to a first quarter 2012 total enrollment of 25. Additionally, there were six women enrolled in the Resource Mothers/Case Management only component of P4HB. Our CMO partners continue to conduct outreach activities to educate moms of very low birth weight infants about the IPC program and encourage them to enroll in the IPC component of P4HB when their pregnancy Medicaid benefit ends.

DISENROLLMENTS

Between January 2012 and March 2012, 369 women were disenrolled from P4HB due to pregnancy. Of those, 139 had been enrolled in P4HB for three months or less. In our fourth quarter 2011 report, we stated that 181 women were disenrolled from P4HB due to pregnancy during all of calendar year 2011 but this number has been revised to 178. This first quarter 2012 disenrollment figure is more than twice that of the disenrollments during the entire first year of the Demonstration. Our data is showing that the number of disenrollments due to pregnancy continues to increase on a monthly basis and we have initiated follow up calls to some of these members to determine the factors leading to these disenrollments. These follow up calls combined with the results from the second client survey (due during the second quarter of 2012) will assist us in determining next steps to decrease these pregnancy related disenrollments. When our data sharing agreement is executed, we will be able to link the P4HB participants who became pregnant with the infants they delivered so that we can track the first year of life costs for those infants and complete the relevant sections of the budget neutrality worksheet. We anticipate this agreement will be executed by June 30, 2012.

EXPENDITURES

Benefit Expenditures

As the number of women enrolled has grown, the total federal and state dollars spent on all aspects of the P4HB program has correspondingly grown. The total spent during the first quarter of 2012 was \$2.19 million, up from a little over \$800 thousand in the last quarter of 2011. During the first quarter, the spending totaled \$2,173,836 for family planning benefits for those enrolled in the family planning component of the demonstration and a total of \$15,600 was spent during the first quarter of 2012 for the women enrolled in the IPC component of the demonstration. All funds were paid through the CMO capitated PMPM arrangement in Georgia's Medicaid program. We excluded from this total the costs for the low income or disabled women receiving Resource Mothers/Case Management only services (\$1,915.65) during the first quarter since their costs cannot be combined with that of the women enrolled in the IPC component of the demonstration.

P4HB COMMUNICATION PLAN and OUTREACH ACTIVITIES

The multi-pronged communications plan for P4HB continues to be followed and while some activities in Phases 1 through 4 are ongoing, the majority of the activities now in play are associated with Phase 5. Each phase is described in Table 2.

Client Outreach

Extensive client outreach was conducted during the first quarter of 2012. Specifically, Right from the Start Medicaid (RSM) workers from 64 different counties made over 265 presentations about the P4HB program to interested individuals in communities throughout the state of Georgia. P4HB client outreach activities ranged from health fairs, to radio public service announcements, to church meetings, and visits to children's hospitals and youth development centers. RSM workers made one-on-one presentations as well as large-scale group information sessions. Attendance at most outreach activities was high, with several activities being attended by more than 1,000 people. For example, in Bacon County, RSM workers promoted P4HB in January 2012 at a Harlem Globetrotter Benefit Basketball game attended by over 1,000 people. In March 2012, RSM workers promoted P4HB to over 2,000 participants of the Belks KIDS FEST in Lowndes County.

A complete list of the P4HB outreach activities for the first quarter of 2012 can be found in the Appendix to this report.

Provider Outreach

Our CMOs are encouraged to continually provide outreach to their providers about P4HB. The CMOs revised their provider and client surveys which were distributed in April 2012. The provider survey addresses CMO network providers' knowledge and understanding of the P4HB program, enrollee eligibility, service coverage and potential barriers that remain. The results of this second survey, which can be used to guide future outreach efforts by both DCH and the CMOs to their provider networks, will be reported in our second quarter 2012 report.

P4HB Marketing

Phase 3 of the Communications Plan details the Consumer-based Outreach activities for P4HB. All of the marketing funding was utilized by the end of the third quarter of 2011, however, we believe the effects of those activities (increased call volume, etc) were clearly seen during the first quarter of 2012.

BARRIERS TO ENROLLMENT

During the first quarter of 2012, the average time (in days) from receipt of an application for P4HB services to referral to an RSM worker went up 38%, from 16.4 days on average in December 2011 to 22.7 days by the end of March 2012. We continue to see a great deal of month to month variation in the average time from application to referral for RSM. A source of this delay includes the following: potential enrollees failed to submit the required documentation in order to assure that a timely approval process could take place, Citizenship verification is now done by State Verification and Exchange System (SVES) and in many cases it means three to four days turnaround time. Initially, citizenship was provisionally verified.

ACTION PLANS

- Auto Enrollment of Women Delivering VLBW infants on Medicaid (under RSM) Eligibility: In collaboration with our enrollment vendor this process should be in place by the end of May.
- 2. Completion of the first Annual Report for P4HB due to CMS in April 2012: We are still awaiting the execution of the data sharing agreement that will allow our evaluation to have access to linked mother/baby data. We anticipate this agreement will be fully executed prior to the close of this current fiscal year June 30, 2012.
- 3. **Maintain ongoing communication with family planning and OBGYN providers**: Communication with family planning and OB/GYN providers to inform them about P4HB will continue throughout the life of the waiver program.
- 4. **Ongoing engagement of providers involved in High Risk Pregnancies**: Providers continue to be encouraged to increase their outreach to these women. A second CMO survey of providers and clients has been implemented with results due in the second quarter of 2012.
- 5. **Ongoing engagement of Georgia's Title X Family Planning Program:**Georgia's Title X Family Planning Program is actively engaged in the P4HB program
- 6. Ongoing collaborations with the Department of Public Health and the Department of Human Services Division of Family and Children Services (DFCS): These collaborations aim to further outreach to teens and young women who are uninsured and either paying out of pocket for family planning services/supplies or going without needed services. Our partnerships help us reach women in the local public health departments' clinics and the DFCS offices. Some of these efforts are reflected in the local meetings held by RSM workers across the state.

EVALUATION ACTIVITIES

The activities during this first quarter of 2012 have included:

- Continued discussions regarding the data sharing agreement between DCH, Thomson Reuters, Inc., Emory University and the Department of Public Health and we anticipate approval prior to June 30, 2012:
- Resolution and documentation of the codes to use for data extracts, methods for defining pregnancy and deliveries and counting infants by birth weight, identifying users of family planning services and the transmitting of files to DCH and Emory;
- Merger of the counts of women in poverty by census tract onto 2009 linked birth/death records for piloting file construction;
- Finalizing the code to measure the time between pregnancies/deliveries on Medicaid for the same women using enrollment data from 2009 through 2010;
- Summarizing results of the CMO surveys of clients and providers for the Annual Report; and 6) Summarizing and testing for significant trends in the use of family planning services and use of low versus higher effective methods of birth control among uninsured and Medicaid insured at Title X clinics in Georgia over the 2009-2011 time period.

Preliminary analysis of these data for eight quarters prior to the waiver and four quarters post the waiver may be included in the first Annual Report along with the results of the initial CMO surveys of providers and P4HB clients.
