OVERVIEW

Georgia's 1115 Demonstration, the Planning for Healthy Babies® (P4HB®) program, began its third year of existence at the beginning of 2013. During this first quarter of 2013, program staff and partners of the P4HB® program continued their efforts to increase awareness of the program while awaiting the official decision concerning the expansion of Georgia's Medicaid program effective January 1, 2014. The care delivery options available under the Affordable Care Act (ACA) include: expanded state Medicaid programs; and health insurance coverage obtained via the Affordable Insurance Exchange. The P4HB® transition plan, submitted to CMS on June 28, 2012, relies on these options for continuity of care once the P4HB® program ends on December 31, 2013. The official decision was made and Georgia's Medicaid program will not be expanding. This decision means that P4HB® participants, who do not meet the current income criteria for full Medicaid benefits, will not be eligible for any Medicaid funded family planning or interpregnancy care (IPC) services starting January 1, 2014. The Eligibility section of this report, describes, in further detail, the impact of Georgia's decision on access to family planning and IPC services and the options that will be available to current P4HB® participants effective January 1, 2014.

This first quarter 2013 report describes: enrollee interest in P4HB[®] as measured by call volume; eligibility information for the family planning and interpregnancy care (IPC) components of P4HB[®]; the number of women actually enrolled in the program; program disenrollments; renewals/recertifications; and the utilization of services by the P4HB[®] participants. Also included in this report are statistics selected from the quarterly reports submitted by the Georgia Families Care Management Organizations (CMOs) who administer the P4HB[®] program for Georgia's Department of Community Health (DCH).

CALL VOLUME




Figure 1: P4HB[®] Total Calls per Month (January 2011-March 2013)

In May 2012, Policy Studies Incorporated (PSI), our P4HB[®] program's call center manager, became a unit of the health services company, MAXIMUS. Since that time, MAXIMUS has provided weekly reports regarding the volume of calls received for the program. As shown in **Figure 1** below, while there was a sharp decline in call volume during the latter half of the fourth quarter of 2012, the call volume levels for the first quarter of 2013 returned to those seen during the third quarter of 2012. Answered call volume in March 2013 was 3,578 calls, representing a 33% increase from the 2,690 calls answered in December 2012. This answered call volume is only 200 calls below the peak call volume for the program of 3,769 calls, reached in May 2012.


ELIGIBILITY

Statistics obtained from the eligibility-related reports for this quarter are identified below.

Number of paper and electronic unique applications for the program by month. (Source: PSI – P4HB Report 001, Run Date: 4/3/2013) Since implementation of the P4HB® program, the *Applications by Month* report has demonstrated continued program growth. During the first quarter of 2013, 4,549 applications were received and by the end of the first quarter of 2013, the program-to-date number of applications received was 40,133. The total number of applications received during the first quarter of 2013 represented a 1.4% increase over the 4,487 applications received during the fourth quarter of 2012 and also represented an 85% increase over the total applications received by the end of the first quarter of 2012 (21,606).

As shown in Figure 2 below, between July and November of 2011, the first year of the P4HB® program, the percentage of applications received and approved each month was at or above 50%. This was not the case during 2012 and for the first quarter of 2013 when the percentage of applications received and approved was below 50% each month. The lowest levels of approvals recorded to date (20%) occurred during the months of November 2012 and February 2013. Application approval rates for March 2013 did show a significant increase over the February 2013 rates and we will continue to monitor this trend during the second quarter of 2013. Our analysis of the *Denial Reason Report* will provide the details regarding these trends. On July 1, 2013, DCH will implement the P4HB® transition plan and the program will no longer accept applications for enrollment.

Number of P4HB[®] applicants including potential auto-enrolled members. As of April 1, 2013, MAXIMUS reported a program-to-date total of 90,967 P4HB[®] applicants for the P4HB[®] program. This total includes individuals who submitted paper or electronic applications for the program plus Medicaid and Peach Care for Kids[®] members who were auto-enrolled into the P4HB[®] program. As reported last quarter, this is not a count of unique individuals, but rather a gauge of continued interest in our program.

Auto-enrollment substantially increases the number of women included in the applicant pool for P4HB[®]. DCH implemented the auto-enrollment process in December 2011 for family planning only services and in April 2012 for IPC services. Women auto-enrolled into family planning only services were either aging out of the Peach Care for Kids[®] program (Georgia's standalone CHIP program) or were scheduled to lose Medicaid eligibility sixty (60) days following their most recent delivery. Women auto-enrolled into

- the IPC component of P4HB[®] were those who had been identified by our CMO partners as having recently delivered a VLBW infant and were scheduled to lose Medicaid eligibility sixty (60) days following the delivery of that VLBW infant.
- Number of individuals deemed eligible for enrollment. Data included in our P4HB® Enrollment by Age Report revealed that by the end of the first quarter of 2013, the program-to-date total (this was incorrectly reported as year-to-date total in previous reports) of women who had been deemed eligible for enrollment into the family planning component of P4HB® was 39,320. This number includes women deemed eligible for enrollment through the auto-enrollment process. For the IPC component of P4HB®, the program-to-date total of women deemed eligible for enrollment was 159, inclusive of women auto-enrolled into the IPC component. Toward the end of the first quarter of 2013, six of the family planning only participants turned 45 and were scheduled to be disenrolled from the program. Our *Enrollment by County Report* showed that only 39,316 women were deemed eligible for family planning only services while 157 women were deemed eligible for the IPC component of P4HB[®]. It is likely these discrepancies are due to missing county of residence information on the applications. Our *Enrollment by County Report* also revealed that by the end of the first quarter of 2013, 102 women had been deemed eligible for the Resource Mothers Only outreach with 100 of them being low income Medicaid (LIM) recipients and two (2) being ABD Medicaid recipients.
- Reasons why Demonstration applications were denied. MAXIMUS identified, in the *Denial Reason Report*, thirty-one unique reason categories why applications for our P4HB® program were denied. During the months of the first quarter of 2013, MAXIMUS reported a total of 3,816 denial reasons which was down from the total of 4,058 denial

reasons reported last quarter. This denial reasons total does not equate to an equal number of denied applications since an application could be denied for multiple reasons. Two denial reason categories stood out as the top categories for applications to be denied during the first quarter. They were the same categories as the ones identified in the fourth quarter report: failure to verify income; and non-response to requests for additional information within fourteen days. Of the 1,299 denial reasons documented for March 2013 alone, non-response within fourteen (14) days of request for additional information in order to complete the application was the denial reason category for 449 denials (34.6% of the denial reasons) and failure of the applicant to verify their income was the denial reason category for 403 denials (31.0% of the denial reasons). All of the denials in the *Denial* Reason Report were linked to applications for the family planning only component of the program. Of all the 41,149 denial reasons reported for the program since its inception, the two most frequent denial reason categories to date are: non-response within fourteen (14) days of requests for additional information (this occurred 12,203 times or 29.7% of all denial reasons) and failure to verify income (this occurred 10,830 times or 26.3% of all denial reasons).

• Reasons why participants were terminated from the P4HB® program. MAXIMUS identified, in the *Termination Reason Report*, thirty-two unique reason_categories why participants were terminated from the P4HB® program. By the end of the first quarter of 2013, 14,093 reasons for termination were reported for the quarter and 47,869 reasons for termination were reported program-to-date. This first quarter termination reasons count represents a 25.1% increase in the number of termination reasons compared with the fourth quarter of 2012. The number of termination reasons does not equate to an equal number of

participants terminated from the program since a participant may be terminated for more than one reason. Two reason categories stood out as the most frequent categories for the terminations during the first quarter of 2013: 1) failure to complete the review process; and 2) having Medicaid or other insurance. Program-to-date, the top three (3) reason categories why P4HB® participants were terminated from the program were, in rank order:

- 1. The woman failed to complete the review requirements within the required time frame of fourteen (14) days. Program-to-date, 42.9% of the family planning only termination reasons were in this category. Many of the terminations linked to this termination reason occurred at the time of renewal of eligibility which is twelve months from the initial eligibility determination date for the program.
- 2. It was determined that the participant was eligible for full Medicaid benefits or other insurance coverage (25.7%).
- 3. Non-RSM cancellation. Program-to-date, 11.0% of the family planning only participants' termination reasons fell into this category. In this scenario, the terminations (cancellations) were handled by our member services team members and were not processed by the RSM outreach project staff. There were 5,260 non-RSM termination reasons by the end of March 2013. We have identified that many of the women terminated for this reason category were found to be pregnant shortly after enrollment into the program and prior to program service delivery. It is for this reason category that we continually strive to reduce the time from application for P4HB® services to CMO enrollment, giving women as early access as possible to contraception. As we stated last quarter, our data suggests that a significant number of women fail to select a CMO within thirty (30) days of the P4HB® eligibility decision.

Since P4HB® services can only be delivered through the CMOs, these women have delayed access to care until they are auto-assigned to a CMO. The auto assignment process adds an additional thirty days to the enrollment timetable. This delay is a prime opportunity for a pregnancy to occur.

Average age of the women determined to be eligible for the P4HB[®] program. The *Family* Planning Enrollment by Age Report documented a program-to-date average age of family planning only eligible women, at the end of the first quarter of 2013, to be 22.8 years and the IPC Enrollment by Age Report documented a program-to-date average age of IPC eligible women to be 28.4 years. The average age of women deemed eligible for the Resource Mother only component of the P4HB® program was 23.8 years for the ABD women (down from 28.7 years in October 2011) and for the LIM women, it was 27.3 years (down from 30.4 years in September 2011). **Table 1** below provides data on the full distribution of women deemed eligible, by age group, and illustrates that the majority (93.6%) of the women deemed eligible for the Family Planning and IPC components of the P4HB[®] program were under the age of 36. Fifty-nine percent of the eligible women were in the youngest age group, 18-22, consistent with the downward trend in the average age of those deemed eligible since program implementation. Of those in the 18-22 age group program-to-date, only 124 were eighteen years of age. This fact is significant in light of the options available to current P4HB® participants once the program ends in December 2013. This will be discussed further below.

Average monthly income of the women deemed eligible. In order for an adult to be eligible for low income Medicaid (LIM) in Georgia, current criteria requires that their monthly income cannot exceed \$235 for a household of one (1); \$500 for a household of four (4). Children ages 6 – 19 (only through the month the child turns 19) are eligible for Right From the Start Medicaid if their families' monthly income does not exceed 100% of the federal poverty level (FPL) or: \$958 for a family size of one (1); \$1293 for a family size of two (2); and \$1963 for a family size of four (4). Comparing LIM eligibility criteria to the 100% FPL levels, an individual is not eligible for Georgia's LIM program if their monthly income, on average, is greater than 25% of FPL.

During the first quarter of 2013, the *Average Income Report* revealed that the average monthly household income for women enrolled in the family planning only component of

P4HB[®] was \$1203.34; and for the IPC component, it was \$1382.67. For P4HB[®] participants enrolled in LIM and receiving Resource Mother only services, their average monthly household income was \$717.63 while P4HB[®] participants enrolled in ABD Medicaid and receiving Resource Mother only services had an average monthly household income of \$628.60.

Combining data from the Average Income Report with data from the Average Age Report, current 18 year old P4HB[®] participants will only be eligible for Medicaid family planning coverage (as Medicaid recipients as of January 1, 2014) through the month of their nineteenth birthday if their families' monthly income qualifies them to transition to full Medicaid benefits effective January 1, 2014. We know that only 124 applicants to date for the P4HB® program were at this age when they were deemed eligible for the program. All other P4HB® family planning and IPC participants, those nineteen years of age and older with incomes that exceed the eligibility thresholds for LIM Medicaid, will not be eligible for any Medicaid-funded family planning or IPC services after December 31, 2013. Effective January 1, 2014, all Americans are required to carry health insurance or they will face financial penalties. Georgia did not elect to expand its Medicaid program and did not elect to establish a state-operated Health Insurance Exchange. As such, the Affordable Insurance Exchange, a federally facilitated marketplace (FFM), will operate in Georgia beginning in October 2013 and will assist in determining Georgians' eligibility for qualified health plans. Premium tax credits, based on family size and income, will be available for Georgia's citizens and legal residents with incomes between 100% and 400% of FPL who purchase coverage through the Exchange. Georgians with incomes higher than

the LIM qualifying levels of 25% of FPL but less than 100% of FPL will not be eligible for subsidies under the Affordable Insurance Exchange. We suspect the majority of our current P4HB® participants fall into this category.

Specific to the IPC component of P4HB®, DCH included in its draft transition plan assessment activities the Georgia Families CMOs would be conducting to determine the care coordination and case management needs of these P4HB® IPC participants. The assessments were to determine which of each CMO's case and disease management programs the IPC participants would transition to for ongoing care. Without the Medicaid expansion, these women will no longer be eligible for Medicaid since the average monthly income for the IPC participants is more than twice the income limit of those eligible for participation in the low income adult Medicaid program with a household size of four (4). Their case management services will be discontinued effective December 31. 2013. Women now enrolled in the IPC component would have been covered for the remainder of their allowed two year enrollment in IPC through an extension of the P4HB® program. However, the 2013 Georgia State Legislature did not include funding for the program in the SFY 14 budget that has been signed by the Governor. As a result, DCH will include language in its transition communications to current P4HB® members that will encourage them to seek assistance in obtaining the best insurance coverage option available to them in Georgia. This assistance will come from the health insurance exchange navigators.

- Average time from application to referral. The number of days observed between the time
 of application and referral is discussed later in the Enrollment section of this report.
- Top 5 County Enrollment: As of the end of the first quarter of 2013 and as shown in Table
 2 below, just over one third (13,156/39,320) of the total number of women deemed eligible

for the family planning only component of the P4HB® program resided in the metro Atlanta counties of Fulton, DeKalb, Gwinnett, Cobb and Clayton.



ENROLLMENT

As of March 31, 2013, a total of 35,681 women were actually enrolled in one of the Georgia Families CMOs to receive P4HB® services (see **Figure 3**). This number includes 35,432 women enrolled in the family planning only component, 135 women enrolled in the IPC component and 114 enrolled in the Resource Mother only services. The drop in total enrollment of 10% identified between November and December 2012 continued into 2013 with a drop of an additional 2.7% from December 2012 to January 2013. While enrollment increased to 35,681 by the end of the first quarter of 2013, this still represents a 6.8% decrease in enrollment of P4HB® participants in a CMO from the November 2012 level of 38,274. These declines in total enrollment resulted from the disenrollment of significant numbers of women who either failed to submit the documentation required for the eligibility redetermination or were unable to be contacted for this redetermination.

During the first quarter of 2013, there was a documented decrease in the time from the receipt of the application for P4HB® to referral to an RSM worker, indicating an improvement in the reporting and enrollment processes from the program to date. The RSM worker has been responsible for verifying a woman's eligibility and sending the eligibility to the PSI unit of MAXIMUS who then communicates with the CMO enrollment unit of MAXIMUS. As shown in **Table 3** below, the average time (in days) from receipt of an application for P4HB® services to referral to the RSM worker decreased from a high of 22.7 days on average in March 2012 to 10.4 days by the end of the first quarter of 2013. While there has been an increase in the average number of days from the RSM request for more information to a PSI response from one (1) day in August 2012 to 4.1 days by the end of March 2013, 4.1 days is still considerably lower than the high of 9.8 days in November 2012.

As reported in our third quarter 2012 report, focus group findings from our evaluation team suggested that women do not receive PSI communications, do not understand what information they should provide, or have difficulty providing the requested additional documentation such as income verification letters from their employers. We also learned previously that women aren't receiving the renewal letters or do not understand what information is needed so that they can renew their eligibility for the program. The March 2013 data suggested there may be some improvement in P4HB® participants' understanding and ability to move through the process.

RENEWALS

For annual renewal enrollment in P4HB[®], letters were sent to enrolled clients two months ahead of their renewal date. These clients were required to resubmit their income documentation and comply with any additional requests for information to remain covered. During the first quarter of 2013, a total of 12,361 renewal letters were sent to eligible P4HB[®] clients. All but 23 of these participants were enrolled in the family planning component of the program. Only 1,081, or 8.7%,

of the eligible P4HB[®] participants complied and completed their renewal applications. We understand from our member services team that a large number of the women dropped had been auto-enrolled into the program during the previous year. The Georgia Families CMOs have initiatives in place to discourage future disenrollments. Some of their activities include the distribution of postcards and automated renewal phone calls to remind participants of the renewal/recertification process (Source: P4HB[®] Renewal Reports RP003 for January, February, and March 2013).

DISENROLLMENTS

During the first quarter of 2013, 113 women were disenrolled from P4HB[®] due to pregnancy that occurred after the first three months following enrollment into a Georgia Families CMO for P4HB[®] services. This was a decline (23.1%) from the 147 women disenrolled due to pregnancy during the fourth quarter of 2012 (NOTE: The number of women disenrolled due to pregnancy was previously reported as six (6) for the fourth quarter of 2012. Our data was reassessed after that report was submitted.)

CMO REPORTS and UTILIZATION OF SERVICES

The following utilization information was made available through the first quarter P4HB® reports prepared by our CMOs. Sources of data in this section of the report include the monthly MMIS report MGD-3823-M, the MCHB Enrollment after EOM Processing report, and the Family Planning/Resource Mother Quarterly CMO Reports.

Amerigroup – DCH's enrollment data revealed that the largest percentage of P4HB[®] participants (42.5%) was enrolled with Amerigroup at the end of the first quarter of 2013. As of March 2013, the DCH data included 15,018 women enrolled in the Family Planning only component, 63

women enrolled in the IPC component, and 73 women receiving Resource Mother/case management only services. In contrast, Amerigroup's first quarter 2013 P4HB® report analysis identified that over the course of the first quarter of 2013, there had been 19,438 unique participants in the P4HB® program. This number obviously exceeds the DCH total count of P4HB® participants enrolled in Amerigroup as of March 2013. Discussions with all three CMOs earlier this quarter identified their practice of counting the number of women enrolled as of the first day of the quarter in question, then adding the new participants received at the beginning of each month during the quarter in order to arrive at their total count for the quarter. This method of counting P4HB® participants does not factor in the women who are disenrolled from the program during the quarter. This practice has led to the discrepancies between the CMOs' reported count of P4HB® participants and the DCH count of P4HB® participants.

Amerigroup also reported that 16,845 participants or 91% of their Family Planning only participants (18,511) did not have a claims history with them prior to joining Amerigroup's P4HB® program. Therefore, no pharmacy data was available to identify the method of contraception currently being utilized by those members. They identified this lack of history with Amerigroup as a barrier for them to obtain accurate contraceptive use data. However, 231 (or 25%) of the 927 current Family Planning only participants who had previously been enrolled with Amerigroup had a known method of birth control, and the most common method was oral contraceptive. Amerigroup reported a slight increase overall in utilization of Family Planning Services from 31% to 33% from quarter four of 2012 to quarter one of 2013.

Regarding outreach activities, Amerigroup's first quarter 2013 P4HB® report stated they had

conducted 28 "Baby Showers" during the quarter with 2,666 individuals participating. At these events, participants were provided with information about the P4HB® program. There were 376 providers' offices contacted during the quarter for new provider orientation, in office presentations, and the sharing of educational materials pertaining to P4HB®. Information was shared with providers and their staff. Amerigroup also updated its call scripting for new participants (as described last quarter) to educate them about the need to report their current method of contraception. Amerigroup plans to submit the new scripting to DCH for approval in the very near future.

Amerigroup reported a total of 166 IPC/RM members during the first quarter of 2013 (48 more than during the fourth quarter of 2012). Of those:

- 19.32% were pending outreach (32 participants) because they were new participants identified near the end of the reporting period. The outcome of the outreach will be reflected in the next quarter's report.
- 18.7% were active participants (31 participants). Of these, 26 participants (84%) had a known method of contraception. Resource Mothers are actively engaging participants to obtain this information and assist participants with scheduling gynecology appointments.
- 22.9% (38 participants) declined program participation. The main reason for declining the program was that participants believed they did not need the services because they had adequate family support and other resources available to them.
- 8.4% (14 participants) disenrolled, were transitioned to another CMO, or had other health insurance.
- 16.3% (27 participants) were referred, but did not meet eligibility requirements.
- 14.5% (24 participants) were unable to be contacted.

Amerigroup reported they had increased the number of unannounced home visits to the IPC participants' most recent known address from 71 visits during the fourth quarter of 2012 to 74 visits during the first quarter of 2013 in an attempt to conduct case management activities with these participants. This additional outreach increased the contact rate for participants with valid and current addresses on file. Amerigroup plans to continuously engage the IPC participants

through the Resource Mothers and provide the IPC participants with educational materials about contraceptive methods. The CMO also scheduled a meeting with the Georgia OB/GYN Society to discuss implementing the use of a reproductive health life plan with P4HB® participants and the P4HB® transition plan for participants who won't qualify for Medicaid after the P4HB® program ends in December 2013.

Peach State Health Plan (Peach State) – DCH's enrollment data revealed that Peach State

Health Plan had the lowest percentage of all P4HB® participants enrolled (19.0%) at the end of the
first quarter of 2013. As of March 2013, this data indicated that 6,764 women were enrolled in the
Family Planning only component, five (5) women were enrolled in the IPC component, and 11

women were receiving Resource Mother/case management only services. Peach State reported in
its P4HB® first quarter 2013 report analysis that it had 8,687 total P4HB® participants of which:
8,656 were enrolled in the family planning only component; 13 were enrolled in the IPC

component; and 18 were enrolled in the Resource Mothers only component. Peach State added that
377 were new participants. The reason for the discrepancy between the Peach State reported
enrollment count and the DCH enrollment count for Peach State is the same as that described
above for Amerigroup.

Peach State's first quarter 2013 P4HB[®] report also described that 1,384 P4HB[®] participants had obtained one or more family planning services during the quarter which was 1,230 fewer participants obtaining family planning services than during the fourth quarter of 2012. Peach State's report indicated that the decline in use of family planning services may have resulted from a decline in physician visits coupled with a reduction in the number of active enrollees. In addition,

Peach State added that 66.3% of their Family Planning only participants had an unknown method of birth control. This percentage was generated from their data query which incorporated all contraceptive codes (including condoms), historical claims and pharmacy data, and self-reported information from participants who spoke with the Resource Mothers staff.

Peach State reported that it implemented new strategies in February 2013 to: track and report contraceptive utilization data each month; and educate participants about the importance of utilizing birth control methods. These new targeted strategies and interventions included: welcome calls to new participants to inform them about family planning program services; a monthly outreach campaign to encourage participants to report their contraceptive method; calls by Member Services representatives to P4HB® participants to solicit their contraceptive method; postcards added to P4HB® new participant welcome packets that focus on the importance of utilizing contraceptive methods; an online web campaign that allows participants who register via the portal to report their preferred/current contraceptive method; and an updated on-hold telephone message that includes information about contraceptives covered by the plan.

Peach State's report analysis explained that: 2,358 new participant welcome calls were made during the first quarter of 2013 to all newly enrolled participants; joint P4HB[®] partnership meetings and activities with the other CMOs and DCH were ongoing; and that program materials were distributed to enrollees monthly and annually. Regarding the IPC and RM participants, 6 of 13 IPC participants were using some form of contraception and 5 of 18 Resource Mother only participants were using some form of contraception. Women enrolled in the IPC and Resource Mothers only components of P4HB[®] will be included in Peach State's continued outreach and education efforts, including the enhanced strategies to encourage each participant's reporting of

their contraceptive use.

Wellcare – DCH's enrollment data revealed that Wellcare had the second highest percentage of all P4HB® participants enrolled (38.5%) as of the first quarter of 2013. This included 13,650 women enrolled in the Family Planning only component, 67 women enrolled in the IPC component, and 30 women receiving Resource Mother/case management only services. Wellcare had the highest number of women enrolled in the IPC component (66). Wellcare reported in its P4HB® first quarter 2013 report analysis that there was a significant decrease in participants newly enrolling in their IPC component (6 in quarter one of 2013, compared to 38 in quarter four of 2012). In addition, during the first quarter of 2013, 20 IPC participants were terminated from the program for the following reasons: six (6) had been enrolled but were found not to meet program criteria, i.e. they had not delivered a VLBW infant; and 14 were disenrolled because Wellcare had not been able to contact them for sixty days or more. Wellcare increased their number of face-to-face IPC visits from 44 to 59 during the first quarter of 2013.

Wellcare reported that based on their claims data, 1,974 women enrolled in the family planning component of P4HB[®] used some form of contraception whereas 11women enrolled in the IPC component of P4HB[®] had a documented form of contraception. The report further identified that most women chose either oral contraceptives or injectable contraceptives as their preferred form of contraception. Wellcare reported that it provided prenatal education to 173 of its Medicaid members, outreached to members that delivered a very low birth weight baby at birthing centers, and mailed educational information to 6,024 P4HB[®] participants about the program's covered services and benefits.

P4HB® OUTREACH ACTIVITIES

As mentioned in the overview and above, extensive client outreach regarding P4HB[®] was conducted during the first quarter of 2013. Each of the CMOs conducted outreach activities, ranging from "Baby Showers" and outreach calls to new members, to provider office visits and distribution of provider educational materials.

During the first quarter of 2013, RSM workers from 94 different counties made 396 presentations about the P4HB® program to interested individuals in communities throughout the state. P4HB® client outreach activities conducted by the RSM workers occurred at a variety of events including health fairs, job fairs, community meetings, school meetings, church meetings, visits to children's hospitals, and visits to youth development centers. In this outreach process, RSM workers conducted one-on-one presentations as well as large-scale group information sessions.

Attendance at most outreach activities was quite high. In February 2013, RSM workers promoted P4HB® to over 400 individuals in Thomas County at the Department of Labor Expo. In March 2013, RSM workers promoted P4HB® to 12,000 individuals in Ben Hill County at the Wild Chicken Festival. Also in March 2013, RSM workers promoted P4HB® to over 2,000 people at the Dawson County Kare for Kids Easter Egg Hunt. A listing of the outreach activities conducted by the RSM Outreach Project staff can be found in **Appendix A**.

Evaluation Activities

The evaluation activities during the first quarter of 2013 included: 1) analysis of the 2009 and 2010 claims and administrative data linked to the vital records for these years to determine total counts of deliveries and infants and agreement on payer source and birth weight distribution between the two data sources; 2) initial decisions regarding creation of analytic files for these 'pre' years;

3) further multivariate analysis of Title X visit data through the third quarter of 2012; and 4) summary and comparisons of responses from the second and third rounds of provider and client surveys. The evaluation team is waiting on the crosswalk for the 2011 claims and vital record linkage and will then summarize these data in the same manner as was done for the 2009/2010 data.

As noted in our 2012 fourth quarter report, the initial analysis of the Title X data showed an increase in the women coming into Title X clinics who were underinsured (private insured but no family planning coverage) and a slight increase in visits where women came into the visit reporting the use of low/medium effective birth control methods but left with a medium/highly effective birth control method. We are in the process of updating the files for the fourth quarter Title X data and repeating the regressions with a quarterly dummy variable and pre/post flag to ascertain whether the changes in trends can be attributed to the Demonstration or to changes in Title X policies. We are continuing to construct a series of data to identify the index and subsequent deliveries for a multivariate analysis of birth interpartum intervals. We will also develop codes to identify a subsequent pregnancy and estimate models on interpartum intervals.

ACTION PLANS

1. Outreach to Neonatal Intensive Care Units (NICUs): DCH and Emory University discussed the development of a webinar for staff members of the NICUs in Georgia. Plans were for this webinar to describe the P4HB®program, the enrollment process, and the IPC services available through P4HB® for women who deliver a VLBW infant being cared for in the NICUs. An e-mail list-serve of the invitees (targeting the NICU medical directors, nurse coordinators, and social workers) was assembled. With the projected transition date for the

- P4HB[®] program so close, DCH and Emory University believe these webinars should not go forward but rather plans should be put into place to clearly inform providers and clients of how women can continue to obtain services when the P4HB[®] program ends.
- 2. **Completion of the first Annual Report for P4HB**[®]: The evaluation team, along with DCH, submitted the Annual Report to CMS in December 2012. In our subsequent conversations with our CMS project officer, we discussed the second Annual Report and issues related to the linkage of mothers and infants within the claims/administrative data files and lags in these data as well as the vital records. We were asked to simply keep CMS informed as to the length of these delays and when they should expect receipt of the second year Annual Report.
- 3. Maintain ongoing communication with family planning and OB/GYN providers:

 Communication with family planning and OB/GYN providers to inform them about P4HB[®] will continue throughout the life of the Demonstration. During the second quarter of 2013, we will focus on the P4HB[®] transition plan and will discuss with the CMOs and providers how program participants should be guided to alternative sources of care or insurance coverage.
- 4. **Ongoing engagement of providers involved in High Risk Pregnancies**: Our CMOs are continually encouraged to increase their outreach to their network providers who provide care for these high risk pregnant women.
- 5. **Ongoing engagement of Georgia's Title X Family Planning Program:** Georgia's Title X Family Planning Program has been sharing data on a quarterly basis with the P4HB® evaluation team at Emory.
- 6. Ongoing collaborations with the Georgia Department of Public Health (DPH) and the Georgia Department of Human Services Division of Family and Children Services (DFCS): These collaborations aim to further outreach to teens and young women who are

uninsured and either paying out of pocket for family planning services/supplies or going without needed services. Our partnerships help us reach women in the local public health department clinics and the DFCS offices. Some of these efforts are reflected in the local meetings held by RSM workers across the state.

7. **Develop and implement an interview/survey for the IPC enrollees:** Our evaluator has developed additional survey questions for clients and providers that focus on knowledge of and opinions about reproductive planning, assessment and counseling. This survey is in the field and we anticipate completed surveys by the end of the third quarter at the latest.

EXPENDITURES

As the number of women enrolled in the P4HB® program has grown, the total federal and state dollars spent on all aspects of the P4HB® program has increased accordingly. The total spent on per member per month (capitation) payments to the Georgia Families CMOs made by DCH during the first quarter of 2013 was \$4.4 million, down 4.7% from the total of \$4.7 million spent in the fourth quarter of 2012. This decrease in quarterly spending from fourth quarter 2012 to first quarter 2013 is due to the decline in the number of women enrolled in the program. As shown in past quarters, the great majority of capitation payments were for those women enrolled in family planning only benefits. A full 96.8% of the total first quarter 2013 payments were for women enrolled in this component of the P4HB® program and these payments totaled \$4.3 million. A total of \$102,960 in capitation payments was made to the CMOs in the first quarter of 2013 for the women enrolled in the IPC component of P4HB® down 1.2% from the \$104,160 paid during the fourth quarter of 2012. We continue to exclude from these totals the costs for the low-income or disabled women receiving Resource Mothers/Case Management only services (\$37,595) during

this first quarter of 2013 since their costs cannot be combined with that of the women enrolled in the IPC component of the P4HB® program. The Budget Neutrality Worksheet for the first quarter of 2013 follows.
