OVERVIEW

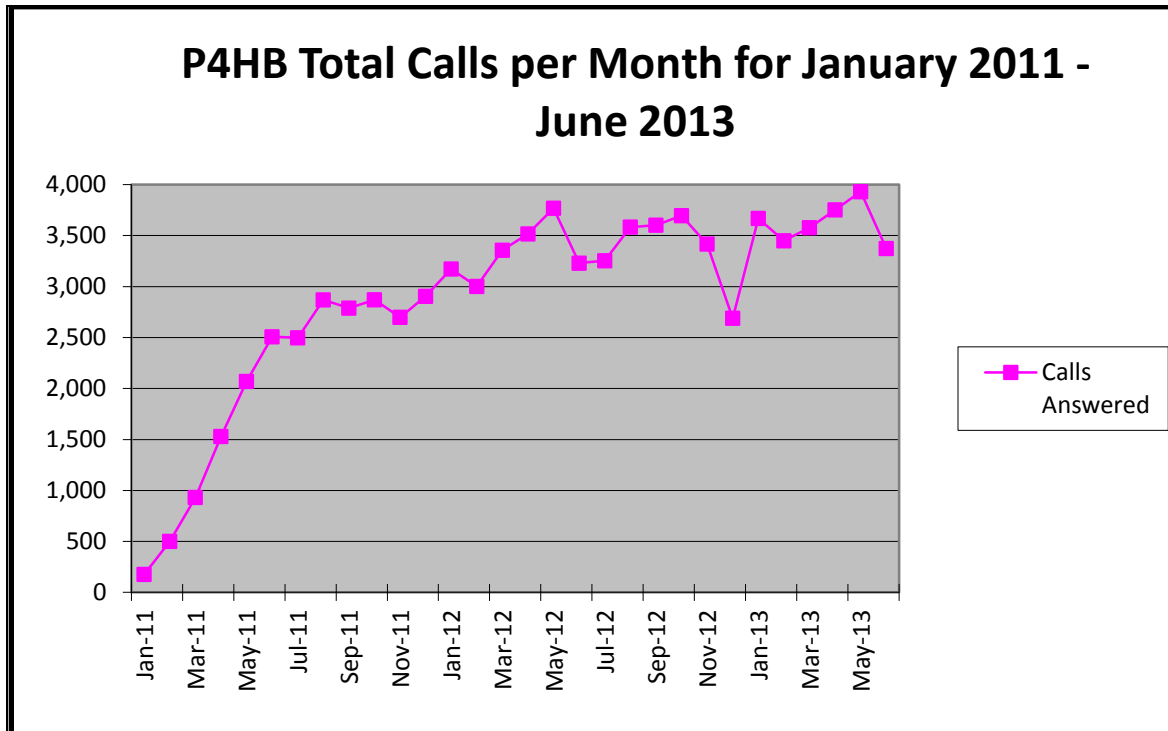
The third year of Georgia's 1115 Demonstration, the Planning for Healthy Babies[®] (P4HB[®]) program, began in January of 2013. This report documents programmatic activities and performance during the second quarter of 2013. Throughout this quarter, outreach activities continued in order to increase awareness of and participation in the program by eligible community members. In June 2013, the Georgia Department of Community Health (DCH) applied for and received approval from the Centers for Medicare and Medicaid Services (CMS) for a temporary extension of the P4HB[®] program through June 2014. DCH expects to submit, by December 2013, a formal application to extend the P4HB[®] program beyond the June 2014 date.

The format and discussion topics for this quarterly report remain unchanged from previously submitted quarterly reports. Topics covered include: enrollee interest in P4HB[®] as measured by call volume; eligibility information for the family planning and interpregnancy care (IPC) components of P4HB[®]; the number of women actually enrolled in the program; renewals/recertifications; and utilization of services by the P4HB[®] participants. P4HB[®] programmatic information gleaned from the quarterly reports submitted by the Georgia Families Care Management Organizations (CMOs) is also included in this report.

CALL VOLUME

PSI/MAXIMUS provided DCH with call volume data for the P4HB[®] program and as shown in **Figure 1** below, answered call volume at the end of the second quarter was below the levels seen at the end of the first quarter of 2013. Despite this decline, call volume has continued to trend upward since the implementation of the Demonstration.

ELIGIBILITY

Statistics obtained from the eligibility-related reports for this quarter are identified below.

- Number of paper and electronic unique individual applications for the program by month.

(Source: PSI – P4HB[®] Report 001, Run Date: 7/1/2013). Following submission of the 2013 first quarter P4HB[®] report, DCH participated in meetings with MAXIMUS to discuss report specifications and the data results for several of the P4HB[®] reports.

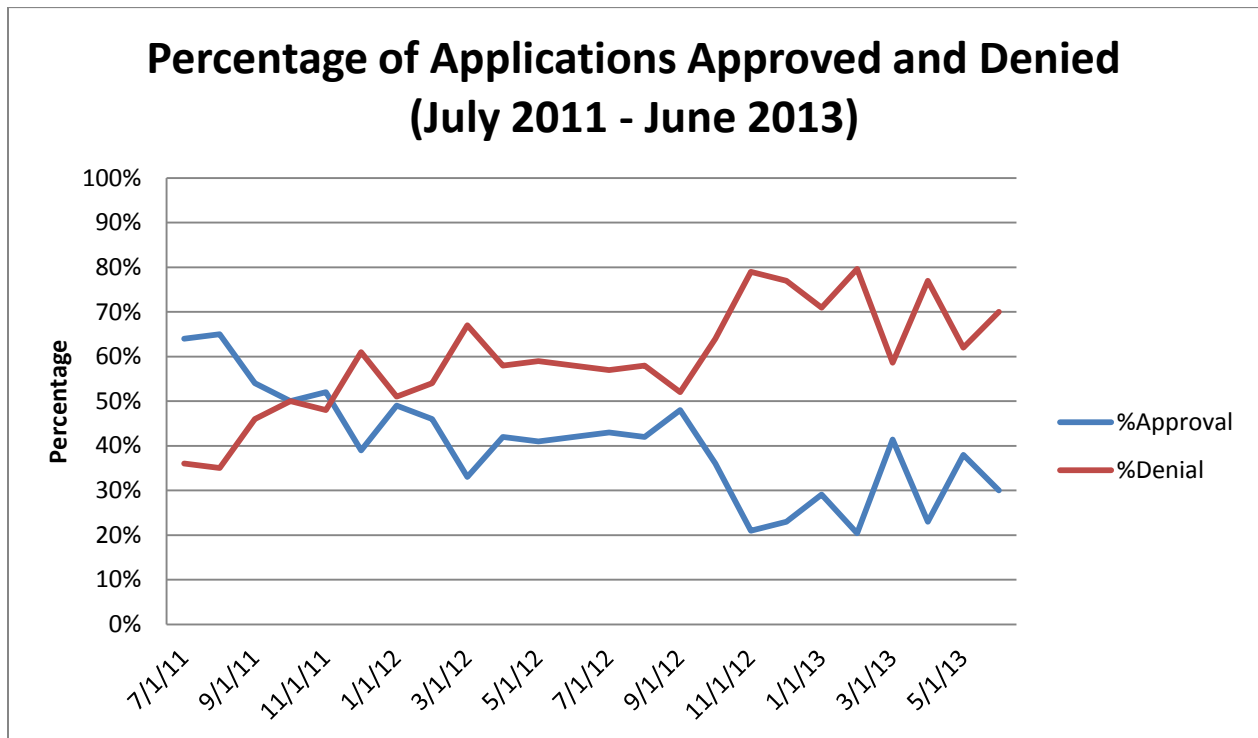
Following those discussions, the *Applications by Month* report’s specifications were revised. From the time the P4HB[®] reports were initiated, all applications for the program were counted even when paper applications duplicated electronic applications and vice versa but the auto-enrollments weren’t included. During the discussions with

MAXIMUS, DCH requested the applications be balanced with actual members. As a result, the auto-enrollments were added to the count and the duplicate paper and electronic applications were removed from the count. The June 2013 program-to-date number of unique paper and web applications totaled 39,187.

The percentage of applications approved each month is shown in **Figure 2** below. At the start of the P4HB[®] program, the percentage of received applications approved each month was at or above 50%. Throughout 2012 and through the second quarter of 2013, the percentage of received applications approved fell below 50% each month.

Application approval rates for April and May 2013 showed a significant decrease over the March 2013 rates. We will continue to monitor this trend.

- Number of P4HB[®] applicants including potential auto-enrolled members. As of July 1, 2013, MAXIMUS reported a program-to-date total of 109,633 applicants for the P4HB[®] program. The total included unique individuals who submitted paper or electronic applications for the program plus former Medicaid and PeachCare for Kids[®] (Georgia's stand alone CHIP program) members who were auto-enrolled into the P4HB[®] program upon disenrollment from either of those programs. Although auto-enrollment significantly increased the number of women included in the applicant pool for P4HB[®], our review of the data over the past year suggested these women did not have a strong interest in P4HB[®] as evidenced by their failure to complete the eligibility redetermination process twelve months following their enrollment into the program. DCH implemented the auto-enrollment process in December 2011 for family planning only services and in April 2012 for IPC services. DCH discontinued auto-enrolling women into the family planning only component of the Demonstration in June 2013. Women auto-enrolled into the IPC component of P4HB[®] were those who had been identified by our CMO partners as having recently delivered a VLBW infant and were scheduled to lose eligibility sixty (60) days following the delivery of their VLBW infant. DCH continued auto-enrolling women into the IPC component of P4HB[®] during the second quarter.
- Number of individuals deemed eligible for enrollment. The specifications for the P4HB[®] *Enrollment by Age Report* were reviewed and as a result, this report was re-named the *Eligibility by Age* report since it simply documents the monthly total of women deemed eligible for enrollment into the P4HB[®] program. This report will no longer be discussed in the quarterly reports.
- Reasons why Demonstration applications were denied. The *Denial Reason Report*

identified thirty-one unique reason categories describing why applications for the P4HB[®] program were denied. MAXIMUS reported a total of 3,907 reasons why applications for P4HB[®] were denied during the second quarter. This number was up slightly from the total of 3,816 denial reasons reported for the first quarter of 2013. The denial reasons total does not equate to an equal number of denied applications since an application could be denied for multiple reasons. Two denial reason categories continued to stand out as the top categories for applications to be denied: failure to verify income; and non-response to requests for additional information within fourteen days. Of the 1,148 denial reasons documented for June 2013 alone, non-response within fourteen (14) days of request for additional information in order to complete the application was the denial reason category for 403 denials (35.1% of the denial reasons) and failure of the applicant to verify their income was the denial reason category for 354 denials (30.8% of the denial reasons). All of the denials in the monthly *Denial Reason Reports* for the second quarter were linked to applications for the family planning only component of the Demonstration.

- Reasons why participants were terminated from the P4HB[®] program. MAXIMUS identified, in the *Termination Reason Report*, thirty-two unique reason categories explaining why participants were terminated from the P4HB[®] program. The number of termination reasons does not equate to an equal number of participants terminated from the program since a participant may be terminated for more than one reason. For the second quarter of 2013, 13,422 reasons for termination from the family planning component were reported and 60 reasons for termination from the IPC component were reported. For each month of the second quarter, the dominant termination reason varied. In April, other insurance was the dominant reason for termination from the family

planning and the IPC components of P4HB[®]. In May, the dominant reason for termination from the family planning and the IPC components was failure to complete the review. In June, there were two dominant reasons for termination from the family planning component – other insurance, and Medicaid eligibility. There was not a dominant termination reason for terminations from the IPC component in June.

- Average age of the women determined to be eligible for the P4HB[®] program. The June 2013 *Average Age Report* documented the average age of women deemed eligible for family planning services as 22.98 years (down from 29.18 years in January 2011) and 28.41 years (up from 24.64 years in April 2011) for women deemed eligible for IPC services. **Table 1** below provides data on the full distribution of women deemed eligible, by age group, and illustrates that the majority (93.6%) of the women deemed eligible for the Family Planning and IPC components of the P4HB[®] program in June 2013 were under the age of 36. Fifty-seven percent of the eligible women were in the youngest age group, 18-22, consistent with the downward trend in the average age of those deemed eligible since program implementation. Of the total 24,921 in the 18 – 22 age group program-to-date, only 383 were eighteen years of age.

- Average monthly income of the women deemed eligible. In order for a family with a non-working parent to be eligible for low income Medicaid (LIM) in Georgia, current criteria requires that their monthly income cannot exceed \$235 for a family of one (1); or \$500 for a family of four (4)¹. Comparing LIM eligibility criteria to the 100% FPL levels, a non-working parent is not eligible for Georgia’s LIM program if their monthly income, on average, is greater than roughly 25% of FPL and for a working parent, if their monthly

income is greater than roughly 50% of FPL.² Eligibility for pregnant women in Georgia extends to 200% of FPL which translates to \$1,916 in monthly income for a family of one and \$3,926 for a family of four. Thus, the P4HB[®] program largely covers women between 25% to 50% FPL and 200% FPL who would not otherwise be eligible for Medicaid unless pregnant.

During the second quarter of 2013, the *Average Income Report* revealed that the program-to-date average monthly household income for women enrolled in the family planning only component of P4HB[®] was \$1,199.19; and for the IPC component, it was \$1,316.77. Both of these averages reflect the higher income eligibility criteria under P4HB[®] compared with LIM. For P4HB[®] participants enrolled in LIM and receiving Resource Mother only services, program-to-date average monthly household income was \$965.23 while P4HB[®] participants enrolled in ABD Medicaid and receiving Resource Mother only services had a program-to-date average monthly household income of \$628.20.

- Average time from application to referral. The number of days observed between the time of application and referral is discussed later in the Enrollment section of this report.
- Top 5 County Enrollment: As of the end of the second quarter of 2013 and as shown in **Table 2** below, just over one third (15,018/43,382) of the total number of women deemed eligible for the family planning only component of the P4HB[®] program resided in the metro Atlanta counties of Fulton, DeKalb, Gwinnett, Cobb and Clayton.

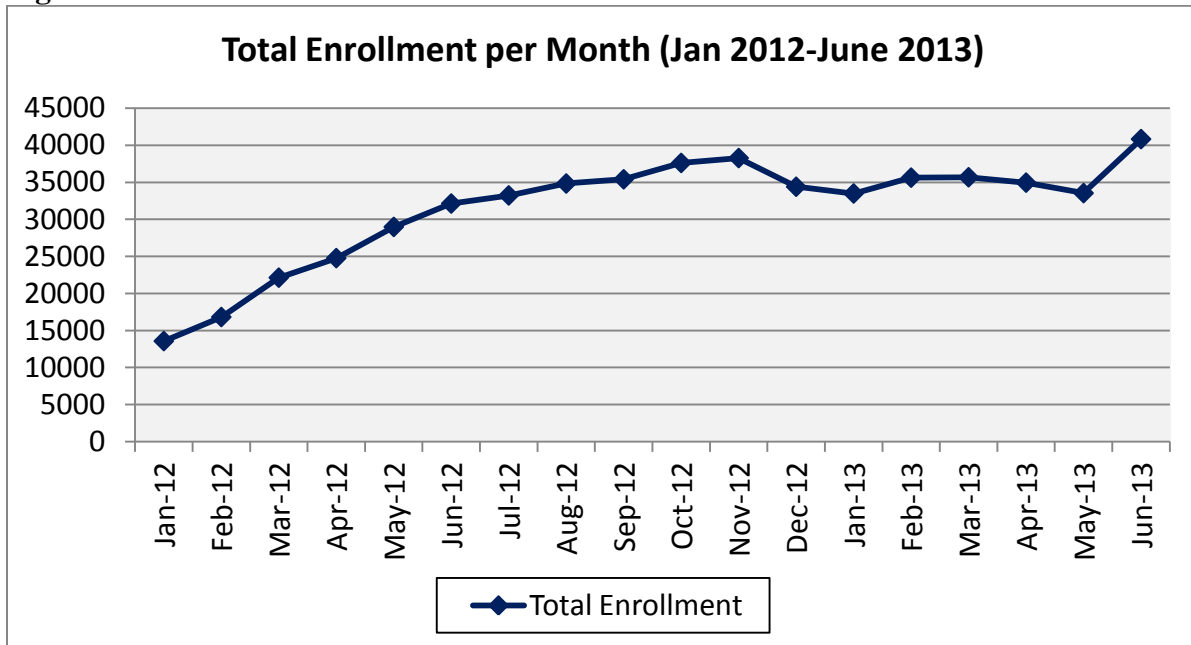

ENROLLMENT

As of June 30, 2013, a total of 40,835 women were actually enrolled in one of the Georgia Families CMOs to receive P4HB[®] services (see **Figure 3**). This number includes 40,593 women enrolled in the family planning only component, 117 women enrolled in the IPC component and 125 enrolled in Resource Mother only services. A 2% drop in enrollment was seen in April 2013 followed by an additional 4% drop in enrollment in May 2013. These declines were followed by a 21.7% increase in enrollment in June 2013, representing an overall 14.4% increase in CMO enrollment of P4HB[®] participants since the end of the first quarter of 2013. Unfortunately, there was a significant decrease in the number of IPC women (from 135 to 117, a 13% decline) enrolled in a CMO in the second quarter compared to the first quarter of 2013.

During the second quarter of 2013, the time from the receipt of the application for P4HB[®] to referral to an RSM worker decreased, reducing the enrollment timeframe for applicants. The RSM worker is responsible for verifying a woman’s eligibility and sending the eligibility to the PSI unit of MAXIMUS who then communicates with the CMO enrollment unit of MAXIMUS. As shown in **Table 3** below, the average time (in days) from receipt of an application for P4HB[®] services to referral to the RSM worker decreased from a high of 22.7 days on average in March 2012 to 11.6 days by the end of the second quarter of 2013. While there has been an increase in the average number of days from the RSM request for more information to a PSI response from one (1) day in August 2012 to 6.3 days by the end of June 2013, 6.3 days is still considerably lower than the high of 9.8 days seen for November 2012.

The June 2013 data, reflecting 27 days from renewal to referral to an RSM worker compared with a high of 31 days at the start of the program, suggested there may be some improvement in P4HB[®] participants' understanding and ability to move through the enrollment process.

RENEWALS

For annual eligibility redeterminations for the P4HB[®] program, letters are sent to enrolled participants two months prior to their renewal date. Participants must resubmit their income documentation and comply with any additional requests for information in order to remain enrolled in the P4HB[®] program beyond their renewal date. During the second quarter of 2013, a total of 6,363 renewal letters were sent to eligible P4HB[®] participants. All but 61 of these participants were enrolled in the family planning component of the program. Unfortunately, only 1,036, or 16.3%, of these eligible P4HB[®] participants completed their renewal applications. We understand from our member services team that a large number of the women who were not

renewed had been auto-enrolled into the program during the previous year. The Georgia Families CMOs have interventions in place to discourage future disenrollments. Some of their interventions include the distribution of postcards and automated renewal phone calls to remind participants of the renewal/recertification process (Source: P4HB[®] Renewal Reports RP003 for April, May, and June 2013).

CMO REPORTS and UTILIZATION OF SERVICES

The following utilization information was made available through the second quarter P4HB[®] reports prepared by the Georgia Families CMOs. Sources of data in this section of the report include the monthly MMIS report MGD-3823-M, the MCHB Enrollment after EOM Processing report, and the Family Planning/Resource Mother Quarterly CMO Reports.

INTERPREGNANCY CARE

Amerigroup

Amerigroup reported they served a total of 160 IPC/RM members at some point during the second quarter of 2013 (6 less than during the first quarter of 2013). Of those:

- a. 6% were pending outreach (11 participants) because they were new participants identified near the end of the reporting period. The outcome of the outreach will be reflected in the next quarter's report.
- b. 24% were active participants (38 participants). Of these, 36 participants (94%) had a known method of contraception. Resource Mothers actively engaged participants to obtain this information and assist participants with scheduling gynecology appointments.
- c. 26% (42 participants) declined program participation. The main reason for declining the program was that participants believed they did not need the services because they had adequate family support and other resources available to them.
- d. 4% (5 participants) disenrolled, were transitioned to another CMO, or had other health insurance.
- e. 13% (21 participants) were referred, because they no longer met eligibility requirements.
- f. 27% (43 participants) were unable to be contacted.

In the second quarter of 2013, Amerigroup reported 63 home visits to the IPC participants' most recent known address in an attempt to conduct case management activities with these

participants. Thirty-six visits (approximately 57%) were successful. The number of these home visits decreased slightly from the first quarter of 2013, when a total of 56 visits (approximately 76%) were successful.

Peach State Health Plan (Peach State)

Peach State reported that 10 of their 13 IPC participants were using some form of contraception and 6 of their 12 Resource Mother only participants were using some form of contraception. Women enrolled in the IPC and Resource Mothers only components of P4HB[®] were included in Peach State's continued outreach and education efforts, including the enhanced strategies to encourage each participant's reporting of their contraceptive use.

Wellcare

During the second quarter of 2013, 11 IPC participants were terminated from the program for the following reasons: four (4) had been enrolled but were found not to meet program criteria after having a tubal ligation; one (1) became pregnant; one (1) moved out of state; and five (5) were disenrolled because Wellcare had not been able to contact them for sixty days or more. Also during this second quarter, Wellcare conducted 46 face-to-face IPC visits, a decrease from the 59 face-to-face visits conducted during the first quarter of 2013.

P4HB[®] OUTREACH ACTIVITIES

As mentioned in the overview and above, extensive client outreach regarding P4HB[®] was conducted by the CMOs, as described above, and by the RSM workers during the second quarter of 2013.

The RSM workers made 367 presentations in 75 counties about the P4HB[®] program to interested

individuals in communities throughout the state. P4HB[®] client outreach activities conducted by the RSM workers occurred at a variety of events including health fairs, job fairs, community meetings, school meetings, church meetings, visits to children's hospitals, and visits to youth development centers. In this outreach process, RSM workers conducted one-on-one presentations as well as large-scale group information sessions. Attendance at most outreach activities was quite high. In April 2013, RSM workers promoted P4HB[®] to over 300 individuals in Fulton County at the West End Mall. In May 2013, RSM workers promoted P4HB[®] to 500 individuals in Clayton County at the Riverdale Town County health fair. In June 2013, RSM workers promoted P4HB[®] to 750 people in Jones County at the Daylily Festival. A listing of the outreach activities conducted by the RSM Outreach Project staff can be found in **Appendix A**.

Evaluation Activities

The evaluation activities during the second quarter of 2013 included: 1) completion of the analysis of the 2009 and 2010 claims and administrative data linked to the vital records and the resulting birth weight distributions among Medicaid insured women; 2) creation of analytic files for the 'pre' and 'post' year of 2011 to measure use of family planning services, number and percent of P4HB[®] family planning only enrollees with evidence of a pregnancy/birth and outcomes of these births; and 3) completion of multivariate analysis of Title X visit data through the first quarter of 2013 on changes in insured status of Title X clients, changes in use of more versus less effective birth control and comparison of these changes among women eligible for P4HB[®] versus those not eligible.

The following summary of the 2009 and 2010 data was discussed with DCH during the past

quarter:

1. The number of Medicaid paid births was declining prior to the demonstration and continued into its first year: 83,014 in 2009; 77,934 in 2010 and 72,280 in 2011.
2. The average paid amount for the infant at delivery increased only slightly from \$3,758 to \$4,037 over these three years.
3. The percentage of the infant records linking to the vital records is similar in 2009 and 2010 at about 89%.
4. The birth weight distribution using claims only is very close to that using the linked vital records for percent very low birth weight at about 2% but differs on the percent low birth weight. [These are preliminary numbers and will change as we adjust the code.]
5. Data for the demonstration will be based on only claims data in our upcoming annual report but we will note that these will change after all years of data are linked to the vital records.

The evaluation team is still waiting on the crosswalk for the 2011 claims and vital record linkage and will then summarize these data in the same manner as was done for the 2009/2010 data.

In addition to updating the Year 1 report, the evaluation team plans to include as much of the following types of analysis as possible in the Year 2 report to discern if there is any evidence of early effects of the Demonstration:

1. Combine the 2009-2012 claims with the Title X data for the same period [omitting those which say Medicaid paid in Title X] to see if the number of family planning visits per uninsured woman in the targeted income range in Georgia has increased over the pre/post waiver period.

2. Use this combined family planning visit file to analyze whether the use of the more effective contraceptives has increased among women in the targeted income range (> 50% but < 200% FPL) who are using family planning services.
3. Measure the number and percentage of family planning only enrollees who become pregnant while enrolled in the demonstration and among them, how many deliver on Medicaid.
4. Compare the birth outcomes of the women participating in the demonstration to other Medicaid [RSM] women who did not. The team will have data through 2012 but will have to measure outcomes based on claims data alone since the link to vital records will not yet be available.
5. Measure the percentage of RSM women with an index birth paid by Medicaid who have a birth within the next 6 months and in turn, next 12 months paid by Medicaid. The team will be able to follow women with index births under RSM in 2009, 2010 and 2011 for six months or through June of 2012 with complete claims for a 12 month follow-up period through June of 2013, knowing births may be slightly understated for this period.

The evaluation team will also assess whether the provider and client surveys denote an improvement in their understanding of the P4HB[®] program over the first two years of its implementation. All of these analyses will be used to inform the state regarding its application for a formal extension of the Demonstration.

ACTION PLANS

1. **Outreach to Neonatal Intensive Care Unit (NICU) Staff:** Emory University's Global

Collaborating Center on Reproductive Health in Atlanta began offering a webinar to Georgia hospital NICU staff to promote their engagement to assist women in enrolling in the Interpregnancy Care component in April 2013. E-mail invitations were sent to NICU medical directors, nurse coordinators, and social workers prior to each planned webinar. To date, one webinar was delivered in April, 2013 (attended by staff from three NICU sites) and another in May, 2013 (attended by staff from five NICU sites); additional dates for the webinar are being planned for the Fall of 2013. The webinar lasts approximately 35 minutes and addresses three learning objectives: (1) To convey the goals and objectives, eligibility criteria, and services covered by the P4HB[®] program (the Family Planning only and the Interpregnancy Care components); (2) To promote understanding of the need for improving women's underlying health status as a strategy for improving Georgia's fetal-infant mortality; (3) To convey how NICU providers can assist women to enroll in the P4HB[®] program, with a focus on the Interpregnancy Care component. After the didactic presentation, the webinar ends with practical advice from a NICU social worker who has been a champion in enrolling women into the P4HB[®] program and then an open question and answer session for the webinar participants.

2. **Completion of the second Annual Report for P4HB[®]:** The evaluation team is in the process of preparing for the second Annual Report.
3. **Maintain ongoing communication with family planning and OB/GYN providers:** Communication with family planning and OB/GYN providers to inform them about P4HB[®] will continue throughout the life of the Demonstration.
4. **Ongoing engagement of providers involved in High Risk Pregnancies:** Our CMOs continually outreach to their network providers who provide care for these high risk pregnant

women.

5. **Ongoing engagement of Georgia's Title X Family Planning Program:** Georgia's Title X Family Planning Program has been sharing data on a quarterly basis with the P4HB[®] evaluation team at Emory. This data is used to update the evaluator's file and complete descriptive and multivariate analyses.
6. **Ongoing collaborations with the Georgia Department of Public Health (DPH) and the Georgia Department of Human Services Division of Family and Children Services (DFCS):** These collaborations aim to further outreach to teens and young women who are uninsured and either paying out of pocket for family planning services/supplies or going without needed services. Our partnerships help us reach women in the local public health department clinics and the DFCS offices. Some of these efforts are reflected in the local meetings held by RSM workers across the state.
7. **On-going Bi-annual Provider and Member surveys:** Our evaluator developed additional survey questions for participants and providers that focus on knowledge of and opinions about reproductive planning, assessment and counseling. The surveys were implemented in April 2013 and results will be included in the next quarterly report.

EXPENDITURES

As the number of women enrolled in the P4HB[®] program has grown, the total federal and state dollars spent on all components of the P4HB[®] program has increased accordingly. The total spent on per member per month (capitation) payments to the Georgia Families CMOs made by DCH during the second quarter of 2013 was \$4.565 million, up 3.6% from the total of \$4.4 million spent in the first quarter of 2013. As shown in past quarters, the great majority of

capitation payments were for those women enrolled in family planning only benefits in P4HB[®]. A full 98% of the total second quarter 2013 payments were for women enrolled in this component of the P4HB[®] program and these payments totaled \$4.476 million. A total of \$89,520 in capitation payments was made to the CMOs in the second quarter of 2013 for the women enrolled in the IPC component of P4HB[®] down 13.1% from the \$102,960 paid during the first quarter of 2013. This decline by 13.1% in capitation payments from quarter one to quarter two reflects a similar decline by 13.3% in the number of IPC women enrolled in a CMO this quarter compared to last quarter. In addition, as shown in the Budget Neutrality Worksheet below, there was a drop in member months from 429 to 373 for this group. We continue to exclude from these totals the costs for the low-income or disabled women receiving Resource Mothers/Case Management only services since their costs cannot be combined with that of the women enrolled in the IPC component of the P4HB[®] program. The Budget Neutrality Worksheet for the second quarter of 2013 follows.
