## OVERVIEW

Georgia's 1115 Demonstration, the Planning for Healthy Babies<sup>®</sup> (P4HB<sup>®</sup>) program, is nearing the end of its second full year of implementation since its roll out in January 2011. During the third quarter of this second year of implementation of P4HB<sup>®</sup>, the Georgia Department of Community Health (DCH) continued its efforts to increase awareness of the program and encourage enrollment among those eligible. This third quarter report describes: interest in P4HB<sup>®</sup> as measured by call volume; the growth in the number of women deemed eligible for enrollment in both the family planning and interpregnancy care (IPC) components of P4HB<sup>®</sup>; the number of women actually enrolled in the program; program disenrollments; and the utilization of services by the P4HB<sup>®</sup> participants. DCH receives quarterly reports from the Georgia Families Care Management Organizations (CMOs) who administer the Demonstration for DCH. During this quarter, DCH revised some of the specifications for the CMOs' quarterly reports to spur more detailed reporting. This third quarter P4HB<sup>®</sup> report also includes details derived from these revised CMO reports.

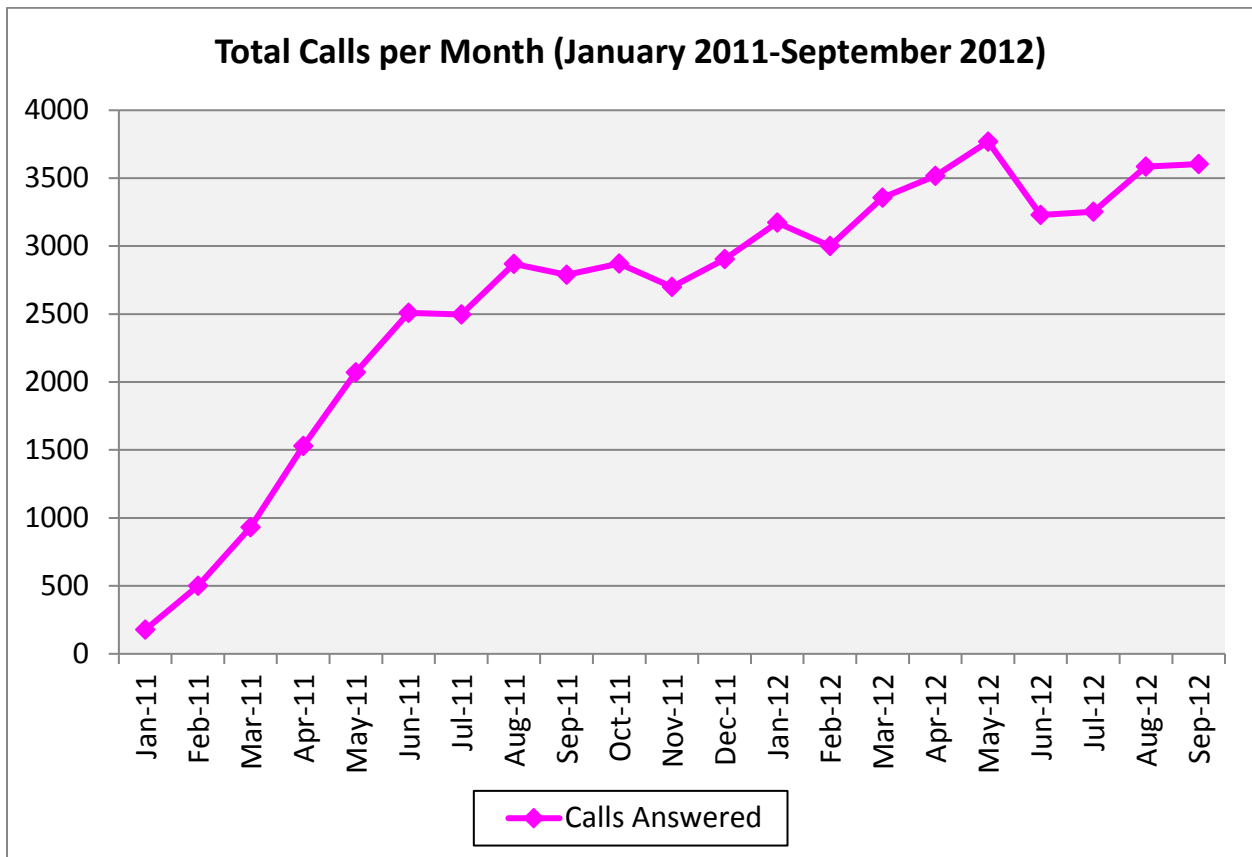
DCH submitted its draft Transition Plan for the P4HB<sup>®</sup> program to CMS in June 2012 and as of this date, DCH still plans to transition women enrolled in the P4HB<sup>®</sup> program, as of December 31, 2013, to an insurance coverage option available under the Patient Protection and Affordable Care Act (PPACA). If the state of Georgia does not expand Medicaid under the PPACA, updates to this draft plan will be included in future P4HB<sup>®</sup> reports.

## CALL VOLUME

DCH receives weekly reports from Policy Studies Incorporated (PSI), our P4HB<sup>®</sup> program's call center manager, regarding the volume of calls received for the program. As shown in **Figure 1** below, we have generally seen an upward trend in call volume since the start of the

Demonstration. While there was a significant drop in call volume during the months of June and July 2012 (these patterns may reflect seasonal trends such as college students leaving for home and then returning), the decline has almost been erased with call volume increasing to 3,603 calls by September 2012. DCH and its partners will continue their outreach efforts to women in the eligible age range.

**ELIGIBILITY**

Statistics obtained from the eligibility-related reports for this quarter are identified below.

- Number of paper and electronic unique applications for the program by month. Since implementation of the P4HB® program, the *Applications by Month* report has

demonstrated continued program growth. The month of August 2012 had the second highest one month total of applications since implementation of the program with 1,946 applications received. Of these, 784 were paper applications and 1,162 were web applications. Altogether for the third quarter, 4,989 applications were received making a program-to-date total of 31,092 applications received. This third quarter total is up from 4,502 applications received during the second quarter of 2012, representing a 10.8% growth in applications.

- Number of P4HB<sup>®</sup> applicants including potential auto-enrolled members. As of October 1, 2012, PSI reported a combined total of 71,843 applicants (these include Medicaid and PeachCare for Kids<sup>®</sup> members soon to be eligible for auto-enrollment into P4HB<sup>®</sup>) for the P4HB<sup>®</sup> program. While this is not a count of unique applications, it does suggest that a significant number of women, to date, have been included in the applicant pool for P4HB<sup>®</sup> likely as a result of our auto-enrollment process implemented in December 2011. The women eligible for auto-enrollment were either aging out of the PeachCare for Kids<sup>®</sup> program (Georgia's standalone CHIP program) or were scheduled to lose Medicaid eligibility sixty (60) days following their most recent delivery.
- Number of individuals deemed eligible for enrollment. Data included in our P4HB<sup>®</sup> *Enrollment by Age Report* revealed that by the end of the third quarter of 2012, the year-to-date total of women who had been deemed eligible for enrollment into the family planning component of P4HB<sup>®</sup> was 39,621. Four of these women had recently turned 45 and were scheduled to be disenrolled. Our *Enrollment by County Report* showed that only 39,618 women were deemed eligible for family planning. This discrepancy was likely due to missing county of residence information on three applications. Additionally, by the end of third quarter 2012, 144 women were deemed eligible for the interpregnancy care

(IPC) component of P4HB<sup>®</sup> and fifty-four (54) women were deemed eligible for the Resource Mothers Only outreach with 51 of them being low income Medicaid (LIM) recipients. We feel that the discrepancy between the number of applications (31,092) and the total number of women deemed eligible for enrollment (39,816 inclusive of women deemed eligible for IPC services) can be attributed to our auto-enrollment process.

- Reasons why Demonstration applications were denied. There were 4,435 denial reasons for the applicants during the third quarter. This number of denial reasons does not equate to an equal number of denied applications since an application could be denied for multiple reasons. All of the denials in the *Denial Reasons Report* were linked to applications for the family planning only component of the program. During the third quarter, two reasons stood out as being the primary reasons for the denials and they included: failure to verify income and non-response to requests for additional information within fourteen days. Of the 33,508 denial reasons-to-date, the top three denial reasons include: non-response for request for additional information in order to complete the application (27.8%); failure of the applicant to verify their income (24.7%); and Medicaid or other insurance coverage is available and documented on the application (15%).
- Reasons why participants were terminated from the P4HB<sup>®</sup> program. There were 4,745 termination reasons during the third quarter and 22,495 year-to-date. This number of termination reasons does not equate to an equal number of terminations from the program since a participant may be terminated for more than one reason. Two reasons stood out as the most frequent reasons for the terminations during the third quarter: failure to complete the review process and Medicaid or other insurance. Year-to-date, the top three reasons why P4HB<sup>®</sup> participants were terminated from the program include, in rank order:

1. It was determined that the participant was eligible for full Medicaid benefits or other insurance coverage (34.5%).
  2. Non-RSM cancellation. Program-to-date, 23.4% of the family planning only participants' termination reasons fell into this category. In this scenario, the terminations (cancellations) were handled by our member services team members and were not processed by the RSM outreach project staff. There were 5,263 non-RSM termination reasons year-to-date. We have identified that many of the women terminated for this reason were found to be pregnant shortly after enrollment into the program and prior to program service delivery. This reason links with our desire to reduce the time from application to CMO enrollment so that women can have as early access as possible to contraception. Our data suggests that a significant number of women fail to select a CMO (through which P4HB<sup>®</sup> services are to be delivered) within thirty (30) days of the eligibility decision. P4HB<sup>®</sup> can only be delivered through the CMOs. These women are subsequently auto-assigned to a CMO but the auto assignment process adds an additional thirty days to the enrollment timetable. This delay is an opportunity for a pregnancy to occur.
  3. The woman failed to complete the review requirements within the required time frame of fourteen (14) days. Program to date, 14.76% of the family planning only termination reasons were identified as this failure. Many of the terminations linked to this termination reason occurred at the time of renewal of eligibility for the program.
- Average age of the women determined to be eligible for the P4HB<sup>®</sup> program. Previous quarterly reports have stated that at the time of implementation of the P4HB<sup>®</sup> program, the average age of the women deemed eligible for the family planning only services component was 29.2 years. As of the end of the third quarter of 2012, the average age for

family planning only women was 22.7 years. This same downward trend is occurring in the women deemed eligible for the IPC component of P4HB<sup>®</sup>. Between September 2011 and March 2012, the average age for IPC eligible women was 30.3 years but in September of 2012, the average age of IPC eligible women was 28.0 years and the program-to-date average age is 28.6 years. The average age of women deemed eligible for the Resource Mother only component of the P4HB<sup>®</sup> program is 24.6 years for the ABD women (down from 28.7 years) and for the LIM women, it is 25.5 years (down from 30.4 years). **Table 1** below provides data on the full distribution of women deemed eligible, by age group, and illustrates that the majority of the women deemed eligible for the Family Planning and IPC components of the P4HB<sup>®</sup> program were under the age of 36 and more than two-thirds of the eligible women were in the youngest age group, 18-22, consistent with the downward trend in the average age of those deemed eligible.

- Average monthly income of the women deemed eligible. We have found that of the women deemed eligible for P4HB<sup>®</sup> services, those ABD Medicaid eligible women

receiving Resource Mother Only P4HB<sup>®</sup> services had the lowest average monthly income of all program participants (\$628.20). This is in contrast to the average monthly income for women deemed eligible for the family planning only component of P4HB<sup>®</sup>, approximately \$1,200.00. These differences are consistent with the state’s income eligibility criteria for the LIM and ABD Medicaid recipients who are only eligible for the Resource Mother Only component of P4HB<sup>®</sup>. The average monthly income that qualifies them for Medicaid is \$698.00. A higher income level is used for the family planning only component, 200% FPL or about \$2,522 per month for a family of two.

- Average time from application to referral. The number of days observed between the time of application and referral is discussed later in the Enrollment section of this report.

As of the end of the third quarter of 2012 and as shown in **Table 2** below, just under one third (12,797/39,621) of the total number of women deemed eligible for the family planning only component of the P4HB<sup>®</sup> program reside in the metro Atlanta counties of Fulton, DeKalb, Gwinnett, Cobb and Clayton although, as noted in earlier quarterly reports, this percentage has declined as the program has grown across the state.

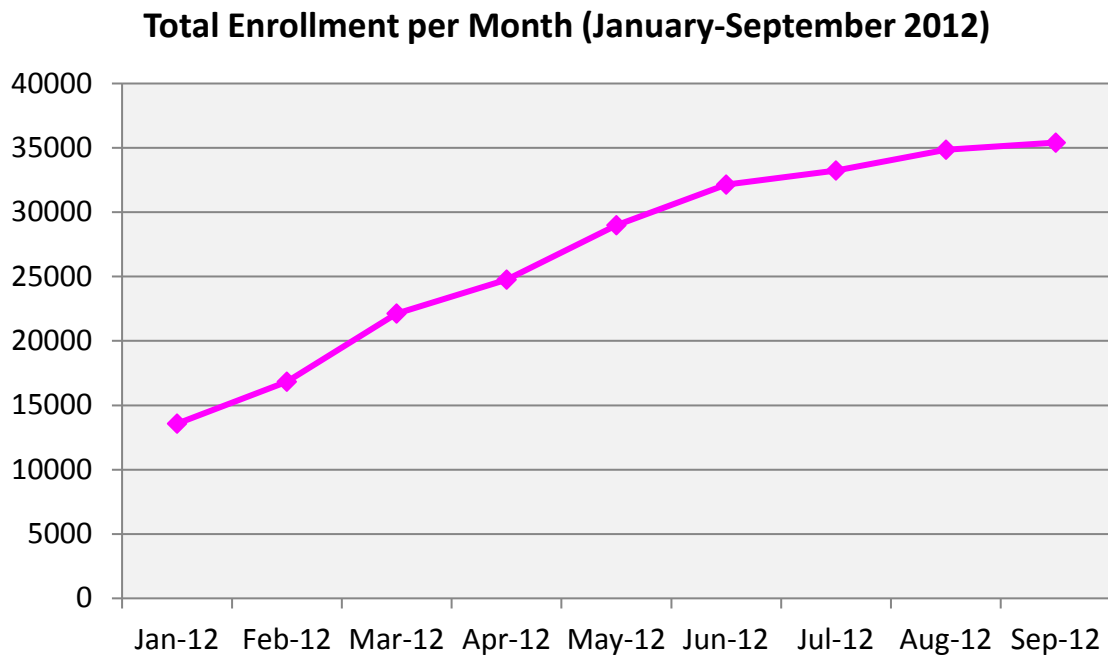


## ENROLLMENT

As of September 1, 2012, 35,410 women had enrolled in one of the Georgia Families care management organizations (CMOs) to receive P4HB<sup>®</sup> services (see **Figure 2**). As mentioned above, implementation of the auto-enrollment process in December 2011 for the family planning only component resulted in a discrepancy between the numbers of direct applications (31,092) and the numbers of women deemed eligible for this component (39,621). It appears the auto-enrollment process increased the number of women eligible for the family planning component by over 25%. Because we have two different information systems tracking the applications and the number of members enrolled in the CMOs, it is difficult to accurately quantify the actual number of P4HB<sup>®</sup> enrollees resulting from auto-enrollment. However, DCH is working to clarify this issue. Auto-enrollment into the IPC component began on April 1, 2012, and by the end of the third quarter of 2012, 144 women had been deemed eligible for the IPC component, more than doubling the second quarter number of 61 deemed eligible. We attribute much of this increase to the auto-enrollment process and hope that we see an even greater impact in the months to come.

There has been a documented decrease in the time from the receipt of the application to referral to an RSM worker. The RSM worker is responsible for verifying a woman's eligibility and sending the eligibility to PSI who then communicates with Maximus, the enrollment broker for the CMOs.

As shown in **Table 3** below, the average time (in days) from receipt of an application for P4HB<sup>®</sup> services to referral to the RSM worker decreased from a high of 22.7 days on average in March 2012 to an average low of about 11 days in each month of the 3<sup>rd</sup> quarter 2012. However, there has been a troubling increase in the average number of days from the RSM request for more information to a PSI response from 1 to almost 5 days, in the last month of this quarter.

We will be investigating this increase in time for PSI to respond to the RSM Outreach Project Workers further.

Regarding the average time from application to referral to RSM, our original thought was that a major delay existed when PSI sent communication to the applicants asking for more documentation. We understand, through focus groups conducted by members on our evaluation team (focus groups), that women sometimes never received those communications or they didn't

understand what additional information was being requested. In other situations, women were asked to provide information that was difficult, such as a letter from their employer documenting their income. Regarding the delay in the renewal eligibility determination, our evaluation team learned that women aren't receiving the renewal letters or do not understand what information is needed so that they can renew their eligibility for the program. Through the focus groups, it appears the documentation requirements for the application and renewal for the program are sources of complaints from the enrollees.

In our previous report, we also mentioned that third-party liability (TPL) for vision and dental services was an issue which affected the P4HB<sup>®</sup> eligible woman's ability to select a CMO in order to receive P4HB<sup>®</sup> services. This issue was resolved in June 2012 when an adjustment was made to the third party liability policy specific for the P4HB<sup>®</sup> participants and a corresponding adjustment was made to the eligibility system.

## **DISENROLLMENTS**

During the third quarter of 2012, 125 women were disenrolled from P4HB<sup>®</sup> due to pregnancy

that occurred after the first three months following enrollment into a Georgia Families CMO for P4HB<sup>®</sup> services. This was a significant decline from the 158 women disenrolled due to pregnancy during the second quarter.

On September 21, 2012, the three Georgia Families CMOs hosted a “Baby Shower” for women currently pregnant. During the shower, information about car seat safety, nutrition, exercise and dental health during pregnancy was discussed. A staff member from the P4HB<sup>®</sup> program attended the “Baby Shower” and spoke with the participants about the P4HB<sup>®</sup> program. Three women shared that they had participated in the P4HB<sup>®</sup> program and found the services were easy to use. The women stated they had enjoyed participating in the program but had decided to discontinue participation because they wanted to have another baby while they were still young – all three were under the age of twenty-five. One of the three women had also delivered a very low birth weight infant with her previous pregnancy. We will be tracking women who disenrolled from P4HB<sup>®</sup> due to pregnancy to determine their birth outcomes and their infants’ first year of life costs. This will occur when the 2011 data are linked with the vital records data from the Georgia Department of Public Health.

## **CMO REPORTS and UTILIZATION OF SERVICES**

The following utilization information was made available through the third quarter P4HB<sup>®</sup> reports prepared by our CMOs.

**Amerigroup** – DCH enrollment data revealed that the largest percentage of P4HB<sup>®</sup> participants was enrolled with Amerigroup (48%) as of the third quarter of 2012. This included 17,034 women enrolled in the Family Planning only component, 35 women enrolled in the IPC component, and 25 women receiving Resource Mother/case management only services.

Amerigroup staff members stated that newly enrolled P4HB<sup>®</sup> participants receive a “Welcome Call” from their Call Center along with a benefit package explaining the P4HB<sup>®</sup> program. Amerigroup reported in its P4HB<sup>®</sup> third quarter 2012 report analysis that, based on the review of their pharmacy claims, 89.3% of the Family Planning only participants had an unknown method of birth control. Of those, 73% did not have a claims history with Amerigroup prior to joining the P4HB<sup>®</sup> program so no pharmacy data was available to identify the method of contraception currently being utilized. They identified this lack of history with Amerigroup as a barrier to obtaining accurate contraceptive use data, stating these women may have: been with another CMO prior to joining Amerigroup for the Demonstration; obtained contraceptives from other designated family planning clinics; purchased over the counter condoms or their partner may have provided the condoms; or they may have obtained contraceptives from their practitioners’ offices. To address this barrier, Amerigroup stated they were considering several interventions, one of which was implementing automated calls with scripting to engage members and capture the contraceptive method used. The CMO also described that capturing data on contraceptive method use was challenging and added that the remaining 27% with an unknown method of birth control had incomplete claims data for their birth control method. They also stated they had implemented the use of new and updated Family Planning and P4HB<sup>®</sup> materials which included post cards that were to be mailed to members in November 2012. Amerigroup further identified that it was difficult to obtain details regarding contraceptive use from pharmacy claims alone and saw this as an opportunity to look for other ways to capture contraceptive method use. The CMO’s report also described the difficulty they have in contacting P4HB<sup>®</sup> participants due to bad addresses and invalid telephone numbers and stated they will continue to work with DCH in an effort to improve the demographic information on file for their P4HB<sup>®</sup> members. Amerigroup reported an increase in utilization of Family Planning Services from 25% to over 33% from

quarter 2 to quarter 3 in 2012 and attributed this increase to the outreach and education efforts they were providing.

Amerigroup also reported that 62% of their IPC members had an identified form of contraceptive in use and stated that members with no known contraceptive method had either declined the program or were transitioning out of Amerigroup. The CMO also stated they had difficulty reaching the IPC members as well due to bad addresses and invalid telephone numbers. Their report described how they made unannounced home visits to the IPC member's most recent known address in an attempt to conduct case management activities with the members and that this outreach had increased the contact rate for members with valid and current addresses on file. They also described that 33% of the IPC members had not previously been enrolled with Amerigroup and therefore they did not have contraceptive claims history from other sources or physician claims history to pull historical data for contraceptive use. They planned to continuously engage the IPC members through the Resource Mother and provide the IPC member with educational materials about contraceptive methods.

**Peach State Health Plan (Peach State)** - DCH enrollment data revealed that Peach State Health Plan had the lowest percentage of all P4HB<sup>®</sup> participants enrolled (22.9%) as of the third quarter of 2012. This data indicated that 8,064 women were enrolled in the Family Planning only component, 33 women were enrolled in the IPC component, and 9 women were receiving Resource Mother/case management only services. Peach State reported in its P4HB<sup>®</sup> third quarter 2012 report analysis that 75% of the Family Planning only participants had an unknown method of birth control. This percentage was generated from their data query which incorporated all contraceptive codes (including condoms), historical claims and pharmacy data, and self reported information from members who spoke with the Resource Mothers staff. The Plan stated

that it would implement new initiatives to address these contraceptive use issues to include the solicitation and tracking of self reported data from members each month regarding their contraceptive method. Peach State also described a decrease in administrative costs for the third quarter, not explained by the drop in enrollment but suggestive of a decrease in service utilization. They defined service utilization as office visits, lab tests, and pharmacy transactions excluding contraceptives. The report analysis explained that: 1,157 new member welcome calls were made in quarter three to all newly enrolled members; joint P4HB<sup>®</sup> partnership meetings and activities with the other CMOs and DCH were ongoing; and that program materials were distributed to enrollees monthly and annually. Regarding the IPC members, 49% of those who were contacted used some form of contraception and home visits were made to outreach members unable to be reached by phone. 31.6% of the home visits were successful.

**Wellcare** - DCH enrollment data revealed that Wellcare had the second highest percentage of all P4HB<sup>®</sup> participants enrolled (28.8%) as of the third quarter of 2012. This included 10,149 women enrolled in the Family Planning only component, 52 women enrolled in the IPC component, and 9 women receiving Resource Mother/case management only services. Wellcare had the highest number of women enrolled in the IPC component (52). Wellcare reported in its P4HB<sup>®</sup> third quarter 2012 report analysis that 14.2% of the women enrolled in P4HB<sup>®</sup> had a claim for contraceptive care and only two of the IPC participants had a claim for contraceptive care during the third quarter. The report further stated that the majority of women chose oral contraceptives which were normally prescribed with several refills. Wellcare encouraged women to have a large supply of oral contraceptives to avoid not having birth control if there was a lapse in Medicaid eligibility. Injectable contraceptives were the second most commonly used contraceptives and they were received on a quarterly basis. Regarding the women enrolled in the IPC component, Wellcare reported that it conducted face-to-face visits at the hospital with

mothers identified as having delivered a VLBW infant. Wellcare also reported that it was impossible to determine the effectiveness of its Resource Mothers outreach or its outreach to pregnant women, considering there was no systematic process ensuring that a member educated by Wellcare would return to the CMO as a Family Planning only or IPC participant upon transition from RSM Medicaid. DCH is working to resolve newly identified transition issues relative to these Wellcare comments.

### **P4HB® OUTREACH ACTIVITIES**

As mentioned in the overview and above, extensive client outreach regarding P4HB® was conducted during the third quarter of 2012. Each of the CMOs conducted outreach activities and RSM workers from 83 different counties made 423 presentations about the P4HB® program to interested individuals in communities throughout the state. P4HB® client outreach activities conducted by the RSM workers occurred at a variety of events including health fairs, job fairs, community meetings, school meetings, church meetings, visits to children's hospitals, and youth development centers. In this outreach process, RSM workers conducted one-on-one presentations as well as large-scale group information sessions. Attendance at most outreach activities was quite high. In Clayton County, RSM workers promoted P4HB® to 3,000 individuals at a Chick-Fil-A Back to School Bash in August 2012. Also in August 2012, RSM workers promoted P4HB® to 2,000 people at the Fannin County Rodeo. In Jeff Davis County, RSM workers promoted P4HB® to 1,300 people at the Back to School - Focus on the Family event in July 2012. A listing of the outreach activities conducted by the RSM Outreach Project staff can be found in **Appendix A**.



## **Evaluation Activities**

The evaluation activities performed during the third quarter of 2012 included: 1) receipt of data for 2009-2011 deliveries and infants as identified by claims/encounter data and a crosswalk of those records which linked to public health birth and fetal death records for 2009-2010; 2) development and approval of tables to be included in the Annual Report to CMS, using the 2011 claims/encounter and administrative data; 3) re-categorization of contraceptive use reported in the Title X data into the World Health Organization (WHO) Tiers 1-4, indicating most to least contraceptive effectiveness; 4) analysis of trends in Title X clinic data based on visits and unique women through the second quarter of 2012; 5) tabling of results on time between pregnancies/deliveries on Medicaid for the same women for CY 2008, 2009 and 2010.

The initial analysis of the Title X data has shown an increase in the women coming into Title X clinics who are underinsured (private insured but no family planning coverage) and a slight increase in visits where women came into the visit reporting the use of low/medium effective birth control method but left with a medium/highly effective birth control method. This analysis will be repeated using the WHO Tiers and a person-based file that is ready for analysis. The analysis of the time between pregnancies/deliveries resulted in patterns indicating a large number of women coming back in with another pregnancy/delivery very soon after the 'index' delivery. This has led us to redefine the coding methodology to better identify the month of the index and subsequent deliveries for this analysis and to develop/test more conservative coding for the counts of deliveries and births for the 1<sup>st</sup> Annual Report.

## **ACTION PLANS**

1. **Outreach to Neonatal Intensive Care Units (NICUs):** DCH and Emory University worked

to develop and implement a webinar for staff members of the NICUs in Georgia. This webinar will describe the P4HB<sup>®</sup> program, the enrollment process, and the IPC services available through P4HB<sup>®</sup> for women who deliver a VLBW infant being cared for in the NICUs. We are developing slides and an e-mail invitation for the webinars and we have assembled an e-mail list-serve of the invitees (targeting the NICU medical directors, nurse coordinators, and social workers). We are targeting early 2013 for the delivery of these webinars.

2. **Completion of the first Annual Report for P4HB:** As of the date of this third quarter 2012 report, the data sharing agreement between DCH, Emory, the Department of Public Health and our DSS vendor has been executed and our evaluator, Emory University, received most of the extracts needed for completion of the Annual Report by the middle of September 2012. The linkage of mothers and infants within the claims/administrative data files had to be redone and was received by Emory in mid-October 2012. Linkage to the public health records has been done for 2009 and 2010 but not for the 2011 data.
3. **Maintain ongoing communication with family planning and OB/GYN providers:** Communication with family planning and OB/GYN providers to inform them about P4HB<sup>®</sup> will continue throughout the life of the Demonstration.
4. **Ongoing engagement of providers involved in High Risk Pregnancies:** Our CMOs are continually encouraged to increase their outreach to their network providers who provide care for these high risk pregnant women.
5. **Ongoing engagement of Georgia's Title X Family Planning Program:** Georgia's Title X Family Planning Program is sharing data on a quarterly basis with the P4HB<sup>®</sup> evaluation team at Emory.
6. **Ongoing collaborations with the Georgia Department of Public Health (DPH) and the**

## **Georgia Department of Human Services Division of Family and Children Services**

**(DFCS):** These collaborations aim to further outreach to teens and young women who are uninsured and either paying out of pocket for family planning services/supplies or going without needed services. Our partnerships help us reach women in the local public health department clinics and the DFCS offices. Some of these efforts are reflected in the local meetings held by RSM workers across the state.

- 7. Develop and implement an interview/survey for the IPC enrollees:** Our evaluator has asked us about the development of interview questions the IPC enrollees that focus on: reproductive health/birth spacing; birth control methods and barriers to getting them; nutrition; chronic conditions; protection from infections; management of stressors and social issues; substance abuse; and dental health. We will work with Emory to develop the interview questions and with the CMOs and their Resource Mothers to conduct the survey using these questions. We have targeted early 2013 as an opportune time to collect this type of information from our IPC mothers as the number enrolled has grown.

## **EXPENDITURES**

As the number of women enrolled in the P4HB<sup>®</sup> program has grown, the total federal and state dollars spent on all aspects of the P4HB<sup>®</sup> program has increased accordingly. The total spent on per member per month payments to the Georgia Families CMOs during the third quarter of 2012 was \$4.34 million, up 21% from the total of \$3.58 million spent in the second quarter of this year. As shown in past quarters, the great majority of the expenditures are for those women enrolled for family planning only benefits; a full 98% of the total third quarter expenses were for women enrolled in this component of the Demonstration, equaling \$4.26 million. A total of \$69,600 was paid to the CMOs in the third quarter of 2012 for the women enrolled in the IPC component of the Demonstration. As noted, funds for each component of the Demonstration

were paid through our CMO capitated PMPM arrangement. We excluded from this total the costs for the low-income or disabled women receiving Resource Mothers/Case Management only services (\$9,698) during this quarter since their costs cannot be combined with that of the women enrolled in the IPC component of the Demonstration.
