OVERVIEW

This fourth quarter (Q4) report for Program Year 3 of Georgia's 1115 Demonstration, the Planning for Healthy Babies® (P4HB®) program, describes performance trends, enrollment and disenrollment trends, utilization of services by program participants, outreach to potential participants, and care management organization (CMO) specific information pertaining to their program participants.

Throughout Q4, DCH saw significant swings in the total number of women enrolled and subsequently participating in the program. Despite these swings in the total enrollment count, the number of IPC participants increased each month during the quarter from 128 in October to 253 in December. This was due, in part, to auto-enrollment of eligible women who have delivered a very low birth weight infant into the IPC component of the program. The increased count of women in the IPC component combined with the count of women enrolled in the Resource Mother Only component led to an increase in the total number of women enrolled in the program who had delivered a very low birth weight infant from 289 in October to 318 in December 2013. On the surface, this increase seemed quite positive. However, the data analysis revealed a different story.

From a national perspective, Q4 ushered in the opportunity for potential P4HB enrollees to apply for full health care coverage through the federally facilitated marketplace (FFM). Based on the average income report for the P4HB program, it was unlikely that current P4HB participants were eligible for subsidized health insurance coverage through the FFM.

CALL VOLUME




Figure 1: P4HB Total Calls (Answered) per Month (January 2011-December 2013)

PSI/MAXIMUS provided DCH with call volume data for the P4HB program and as shown in **Figure 1** below, answered call volume at the end of Q4 was below the levels seen at the end of the third quarter of 2013, though a slight increase in calls occurred in December 2013. These results parallel the changes seen in the P4HB enrollment counts for this quarter. When using call volume as the barometer of interest in the program, Figure 1 demonstrates that interest remained steady between March 2012 and October 2013 then began a slow decline. We will continue to analyze call center and other P4HB data to gauge ongoing interest in the program.

ELIGIBILITY

Reports based on Q4 P4HB program data are discussed below.

- Number of paper and electronic unique individual applications for the program by month. (Source: PSI P4HB Report 001, Run Date: 1/8/2014). The December 2013 program-to-date number of unique paper and web applications totaled 43,534 and the majority of the applications submitted were web-based applications. We will no longer report the number of P4HB applicants including potential auto-enrolled members since we have discontinued auto-enrolling women into the family planning component of the program.
- Reasons why Demonstration applications were denied. During Q4, the top two reasons cited for denial of applications for the P4HB program were non-response within 14 days and failure to verify income. Since the implementation of this program, DCH has identified a consistent pattern of women failing to complete the application process with these two reasons being the most often reported. It is not clear why some of these women initiated the application process then failed to follow through. This pattern occurs primarily with the applications for the family planning only component of P4HB.
- Reasons why participants were terminated from the P4HB program. For Q4, failure to complete the review was the dominant reason for termination from both the family planning and IPC components of P4HB. This continues to be one of the top reasons why participants were terminated from the P4HB program.
- Average age of the women determined to be eligible for the P4HB program. By the end of Q4, the average age of women deemed eligible for family planning services program-to-date was 23.3 years (comparable to the 23.1 years program-to-date reported in Q3 of

2013). For women deemed eligible for IPC services, the average age program-to-date was 28.5 years, the same average age reported in Q3 of 2013. **Table 1** below provides data on the full distribution of women deemed eligible, by age group, in December 2013 and illustrates that the majority (92.4%) of the women deemed eligible for the Family Planning and IPC components of the P4HB program in December 2013 were under the age of 36. Fifty percent of the eligible women were in the youngest age group, 18-22. Of the total 16,473 in the 18 – 22 age group, only 89 were eighteen years of age. Eighteen years of age is the cutoff date for Medicaid and PeachCare for Kids enrollment when the young woman lives with her family. By age 19, most of these young women have lost their Medicaid or PeachCare for Kids coverage.

- By the end of Q4, the *Average Income Report* revealed the average monthly household income for all women enrolled as of December 2013 in the family planning only component of P4HB was \$1224.90. For the IPC component, the average monthly income for all IPC enrolled women enrolled as of December 2013 was \$1461.53. In Q1 of 2013, the Average Income Report indicated the average monthly household income for all women enrolled in the family planning only component in January 2013 was \$1206.45 and for the IPC component, it was \$1364.15. Comparing Q1 to Q4 of 2013, the average monthly income increased during the year but was still below the highest average income for family planning enrollees reported in April 2011 and for IPC enrollees reported in June 2011. Of interest was the fact that the report indicated the number of women with earned income decreased from 5831 to 5685 during the quarter. The report identified that a significant number of enrollees reported no income. This metric is concerning since childless women without income are not eligible for low income Medicaid (LIM) benefits and would only be eligible for Medicaid benefits if they were blind or disabled. The P4HB program provides access to annual examinations, family planning counseling and access to contraceptives for these women who would otherwise not have any regular health insurance coverage.
- Average time from application to referral. The number of days observed between the time of application and referral is discussed later in the Enrollment section of this report.
- <u>Top 5 Counties Enrollment</u>: As of the end of Q4 and as shown in **Table 2** below, just over one third (11,686/32,561) of the total number of women deemed eligible for the family planning only component of the P4HB program resided in the metro Atlanta counties of Fulton, DeKalb, Gwinnett, Cobb and Clayton. These counties have continued

to have the highest numbers of women deemed eligible for the P4HB program since program inception.

ENROLLMENT

As of December 31, 2013, a total of 32,008 women were actually enrolled in one of the Georgia Families CMOs to receive P4HB services (see **Figure 2**). This number included 31,690 women enrolled in the family planning only component, 253 women enrolled in the IPC component and 65 enrolled in Resource Mother only services. Enrollment in the P4HB program peaked at the beginning of Q3 of 2013 but since that time, there has been an 18.5% decrease in CMO P4HB enrollment. This decline in total enrollment was primarily due to a decline in enrollment in the family planning only component which was down 18.8%. As previously stated, enrollment in the IPC component increased during Q4 from 104 to 253, a 147.1% increase.

The Q4 time from the receipt of an application for P4HB to referral to an RSM worker was 17.5% higher (11.4 days) than during the fourth quarter of 2012 (9.7 days). However, there was a

significant decrease over the past year in the average number of days from the RSM request for more information to a PSI response, from 6.5 days in December 2012 to 3.5 days in December 2013. The 3.5 days is considerably lower than the high of 9.8 days recorded for November 2012. By the end of this quarter, the average time from renewal to referral to the RSM worker was 26 days, one day shorter than the average time in December 2012.

RENEWALS

For the annual eligibility redeterminations for the P4HB program, letters are sent to enrolled participants two months prior to their renewal date. Participants must resubmit their income documentation and comply with any additional requests for information in order to remain enrolled in the P4HB program beyond their renewal date. During Q4, a total of 10,127 renewal letters were sent to eligible P4HB participants. All but 32 of these participants were enrolled in the family planning component of the program.

Unfortunately, only 1,187, or 11.7%, of these eligible P4HB participants completed their renewal applications (Source: P4HB® Renewal Reports RP003 for October, November and December 2013). The majority of these women had been auto-enrolled into the program during 2012. As reported previously, DCH discontinued the auto-enrollment process for the family planning only component of the program in June 2013. Although the CMOs continue to encourage renewals and dissuade disenrollment from the program by mailing postcards and conducting automated renewal phone calls to remind participants of the renewal/recertification process, these interventions do not appear to be very effective.

CMO REPORTS and UTILIZATION OF SERVICES

The following utilization information was made available through the Q4 P4HB reports prepared by the Georgia Families CMOs. Sources of data in this section of the report include the monthly MMIS report MGD-3823-M, the MCHB Enrollment after EOM Processing report, and the Family Planning/Resource Mother Quarterly CMO Reports. **Table 3** summarizes the main findings for each CMO regarding participant service utilization during Q4.

WellCare	DCH's enrollment data revealed that 39.1% of the total participants in the P4HB program were enrolled with WellCare at the end of Q4. 12,444 women were enrolled in the Family Planning only component, 64 women were enrolled in the IPC component, and 3 women were receiving Resource Mother/case management only services. INTERPREGNANCY CARE

Amerigroup

Amerigroup reported that over the course of Q4, they served a total of 155 IPC and Resource Mother unique enrollees at some point during the fourth quarter of 2013 (29 less than during the third quarter of 2013). Seventy-five of the 155 were IPC enrollees and 80 were Resource Mother enrollees. Of those:

- Only 10% were active participants (16 participants) but all 16 (100%) had a known method of contraception. Resource Mothers actively engaged participants to obtain this information and assist participants with scheduling gynecology appointments.
- 52% (81 participants) declined program participation. The main reasons for declining the program were that participants were not interested in the program or felt they did not need the services because they had adequate family support and other resources available to them. These women will be disenrolled.
- 10% (15 participants) no longer met eligibility requirements and were subsequently disenrolled.
- 16% (25 participants) were unable to be contacted.

In Q4, Amerigroup reported 24 home visits to the IPC participants' most recent known address in an attempt to conduct case management activities with these participants. The number of these home visits remained about the same from the third quarter of 2013, when a total of 25 home visits were made.

Peach State Health Plan (Peach State)

Peach State reported that 12 of their 84 IPC enrollees were active IPC participants using some form of contraception during Q4. Women enrolled in their IPC and Resource Mothers only components of P4HB were included in Peach State's continued outreach and education efforts, including the enhanced strategies to encourage each participant's reporting of their contraceptive use. Home visits were also conducted with members who were unable to be reached.

WellCare of Georgia

WellCare reported that during Q4, 24 new IPC members were added to the plan and 11 IPC participants were terminated from their program for the following reasons: ten (10) lost eligibility and one (1) became pregnant. Also during Q4, Wellcare conducted 32 face-to-face IPC visits, a slight decrease from the 25 face-to-face visits conducted during the third quarter of 2013.

P4HB OUTREACH ACTIVITIES

Outreach to providers, members, and prospective participants regarding the P4HB program was conducted by the CMOs and the RSM workers during Q4. The RSM workers made 277 presentations in 59 counties about the Georgia Medicaid programs including the P4HB program. The RSM workers' outreach activities occurred at a variety of events including health fairs, job fairs, community and school meetings, church meetings, and through visits to youth development centers. A listing of the outreach activities conducted by the RSM Outreach Project staff can be found in **Appendix A.** We will discontinue including these outreach activity reports in the Program Year 4 quarterly reports since we have learned that the outreach provided by RSM

Outreach Project staff has broadened to include information about all areas of Medicaid with P4HB included in that overview. We have not been able to measure the effectiveness of these outreach activities to date. We have submitted a request to the DCH Communications Team to prepare a new communication plan for the P4HB program and when that plan is finalized, we will include those details in the quarterly reports.

CMO MEMBER SURVEY RESULTS

Because of data issues identified in the previously submitted second annual report, the evaluator focused their attention on making the necessary revisions to the annual report in order to resubmit it with this Q4 2013 report. As such, work was not done on the analysis of the fifth round of survey results. The planned analysis of the fifth round of survey results was postponed and will be included in the Q1 2014 P4HB Report which will be submitted to CMS in May 2014.

EVALUATION ACTIVITIES

Emory University, the P4HB program evaluator, reported the following evaluation activities that were underway during Q4:

1) Completion of analysis of counts of deliveries and infants based on ICD-9 rather than DRG codes over the 2009-2012 period; analysis of linked claims and vital records and the resulting birth weight distributions among Medicaid paid births; analysis of 'pre' and 'post' years of 2009-2012 of time to next pregnancy/delivery for RSM women; analysis of pregnancies/deliveries (and birth outcomes) among women participating in the family planning only and IPC components of P4HB; analysis of 2009-2012 data on the use of family planning services pre/post P4HB implementation among Medicaid enrolled women and use of family planning services among women in the 25% to 200% FPL

income strata through either Title X or Medicaid funding; and analysis of Title X visit data through the first quarter of 2013 on changes in insured status of Title X clients, changes in use of more versus less effective birth control and testing of significance in the changes among women eligible for P4HB versus those not eligible. These analyses were used to complete the Year 2 Annual Report initially submitted to CMS in December 2013. Some of the key findings include:

Use of Family Planning:

- Use of contraceptives at Title X clinics shifted toward long-acting, reversible contraceptives (LARCs) based on descriptive and multivariate analysis;
- Use of family planning services among all Medicaid enrolled women ages 18-44 increased between 2009 and 2012;
- The growth in family planning services paid for by Medicaid or Title X did not increase enough to result in a growing percentage of all women < 200% FPL with a family planning or birth control visit over the 2009-2012 time period; but
- Users in both the Medicaid and Title X sectors shifted toward greater use of LARCs by 2012.

Trends in Births/Costs:

 Medicaid paid births were declining prior to implementation of the P4HB program and they have continued to decline through CY2011 but rose in CY2012 following overall patterns at the state level; The percentage of very low birth weight infants remained close to 2.0% each year between 2009 -2012 based on Medicaid claims; and between 2009-2011 based on linked claims and vital records.

Pregnancy/Birth Experiences of P4HB Enrollees:

- Total births to P4HB enrollees were less than expected given the fertility rates cited in the DCH Planning for Healthy Babies Concept Paper used in the application process¹;
- A small percentage of IPC enrollees experienced a pregnancy after enrolling in the P4HB program and one had a live born delivery paid by Medicaid; but
- There were no repeat VLBW births among the IPC enrollees.

Changes in Other Outcomes:

- The percentage of all RSM enrollees with a repeat pregnancy within 6 months of the index birth remained close to 3% during the 2009-2012 time periods;
- Small percentages of IPC women were using services in 2011 but this increased in 2012
 with most of them using services for acute conditions. The use of services by IPC
 participants for chronic conditions increased and the most common service was for the
 management of hypertension.

Following submission of the Year 2 Annual P4HB Report in December 2013, DCH and the evaluation team were made aware that the actual monthly indicator of enrollment in P4HB, which requires enrollment in a CMO, was not provided to Emory. This resulted in inaccurate counts of births to enrolled P4HB participants. The evaluation team at Emory has since obtained

this data and is using it to revise the analysis of key outcomes reported in the December 2013 edition of the P4HB Year 2 Annual Report. The revised P4HB Year 2 Annual Report will accompany the submission of the Q4 2013 Quarterly P4HB Report.

ACTION PLANS

- Completion of the revisions to the Year 2 Annual P4HB Report originally submitted to CMS by DCH on December 20, 2013.
- Maintain ongoing communication with family planning and OB/GYN providers.
 Communication with family planning and OB/GYN providers to inform them about P4HB will continue throughout the life of the Demonstration.
- Ongoing engagement of providers involved in High Risk Pregnancies. The CMOs
 continually outreach to their network providers who provide care for these high risk pregnant
 women.
- 4. Ongoing engagement of Georgia's Title X Family Planning Program. Georgia's Title X Family Planning Program has been sharing data on a quarterly basis with the P4HB evaluation team at Emory. This data is used to update the evaluator's file and complete descriptive and multivariate analyses.
- 5. Ongoing collaborations with the Georgia Department of Public Health (DPH) and the Georgia Department of Human Services Division of Family and Children Services (DFCS). These collaborations aim to further outreach to teens and young women who are uninsured and either paying out of pocket for family planning services/supplies or going without needed services. Our partnerships help us reach women in the local public health clinics and the DFCS offices. Some of these efforts are reflected in the local meetings held by RSM

- workers across the state.
- 6. P4HB member and provider surveys. In the Q3 2013 report, we reported the results from the first four waves of the member surveys and we presented the provider results from the first four waves in the Year 2 Annual P4HB Report. The CMOs distributed a fifth round of P4HB provider and member surveys in August and September 2013. These results will be analyzed and reported in the Q1 2014 P4HB report.

EXPENDITURES

As the number of women enrolled in the P4HB program fluctuated over time, the total federal and state dollars spent on all components of the P4HB program fluctuated accordingly. The total spent on per member per month (capitation) payments to the Georgia Families CMOs made by DCH during Q4 was \$4.3 million, down 15.7% from the total of \$5.1 million spent in the third quarter of 2013. This was due to the decline in enrollment in Q4 of 2013. As shown in past quarters, the great majority of capitation payments were for those women enrolled in family planning only benefits in P4HB. A full 96% of the total Q4 capitation payments were for women enrolled in the family planning only component and those payments totaled \$4.1 million. The decrease in total payments parallels the decrease in member months for this group, from 119,846 in Q3 of 2013 to 98,617 in Q4.

A total of \$125,280 in capitation payments was made to the CMOs in Q4 for the women enrolled in the IPC component of P4HB, up 83.2% from the \$68,400 paid during the third quarter of 2013. This increase in capitation payments from Q3 to Q4 reflects an increase of 143.3% in the number of IPC women enrolled in a CMO during Q4 compared to Q3 and in turn, an 83.2% increase in their member months. While the number of women enrolled increased, many were disenrolled for the reasons previously described in the CMOs' reports. In addition, as

shown in the Budget Neutrality Worksheet below, there was an increase in member months from 295 to 522 for this group.

We continue to exclude from these totals the costs for the low-income or disabled women receiving Resource Mothers/Case Management only services since their costs cannot be combined with that of the women enrolled in the IPC component of the P4HB program. The Budget Neutrality Worksheet for Q4 follows.

We note that the P4HB program now has enough of a follow-up period that the first year of life infant costs for those born in 2012 can be estimated by birth weight and included in the second section of the budget neutrality worksheet. Because of the need for revisions to the Year 2 Annual Report, planned revisions of the CY 2012 budget neutrality worksheet with the first year of life infant costs for infants born in 2012 will be submitted in May 2014.
