## **OVERVIEW**

The Georgia Department of Community Health (DCH) was granted authority by CMS to expand access to family planning services under the Planning for Healthy Babies (P4HB) program to newly qualified women ages 18 through 44 years if they meet income and other eligibility requirements. This demonstration began January 1, 2011 and is scheduled to end December 31, 2013. This report provides information on several operational aspects of P4HB through the third quarter of the waiver's operation, which ended September 30, 2011.

Pursuant to the requirements of this Section 1115 Demonstration, the data and analysis contained herein include the following elements:

- Total number of enrollees;
- Total number of participants;
- Total expenditures;
- Updated budget neutrality worksheet;
- Events occurring during the quarter, or anticipated to occur in the near future that affect health care delivery, benefits, enrollment, grievances, quality of care, access, pertinent legislative activity, eligibility, verification activities and other operational issues;
- Action plans for addressing any policy and administrative issues identified;
- Evaluation activities and interim findings.

The quarterly report presents Georgia data on several measures of progress for the waiver along with an analysis of the status of the various operational aspects of the Demonstration.

## **ELIGIBILITY, ENROLLMENT AND PARTICIPATION**

We report on enrollee counts from two sources of data. The first reports on all applications, denials and eligibility counts through the end of the third quarter (September 2011). We also provide a summary of the counts of family planning (FP) and Interpregnancy Care (IPC) enrollees and participants as reported

by the three CMOs through the end of September.

In this third quarter, there has continued to be a significant amount of growth in women contacting the state about P4HB, number of women applying for benefits, and number of women enrolled in the waiver. For example, the total number of unique women calling in each month to ask about P4HB has steadily increased from 317 in January to 3,168 in the month of September alone; the year to date total of women calling the Ft. Pierce call center to get information equaled 19,080. The time spent on the phone with the women calling in has held pretty steady at 4.5 to 5.5 minutes. As information about P4HB continues to spread throughout the state, the number of calls should continue to increase and ultimately, translate into continuing increases in those deemed eligible and eventually, enrolled for services.

At the state level, there were 6,508 women deemed eligible for Planning for Healthy Babies (of these, 6,494 were eligible for FP only Benefits and 14 for IPC Benefits) following review of their applications and supporting materials as of the end of September 2011. This indicates more than a doubling in the number of women deemed eligible from the 2,962 found eligible at the end of the 2nd quarter of P4HB. As was true in the 2nd quarter of P4HB, the majority (90%) of these women are under age 36 with over one-third (37%) in the youngest age group, 18-22, and another thirty seven percent, ages 23-29. The remaining 26% are 30 years of age or older but only 3% of the women deemed eligible for P4HB are over age 40.

There were only 5 women deemed eligible for the IPC component in the 2<sup>nd</sup> quarter. However, as of the end of September, there were nearly 3 times as many (14) women deemed eligible for this component and its more extensive benefits.

The data in Table 1 again indicate there is a concentration of the 6,508 eligible women within the metro-Atlanta counties (Fulton, DeKalb, Gwinnett and Cobb) and the nearby county of Clayton. The percentage of all eligible women residing in these five counties equaled 33% (2,145/6,494) in the third quarter. This percentage is slightly higher than it was in the 2<sup>nd</sup> quarter (30%) but still much lower than

it was in the first quarter (86%), indicating that women in other metro and rural counties of Georgia are increasingly learning about P4HB and making applications to join the program.

The total number of eligible women reported as being actually enrolled in a CMO for FP or IPC benefits as of the end of September was again, far below the 6,508 reported as eligible at the state level. Across all three CMOs, only 1,898 women were reported as actually enrolled, less than a third (30%) of those deemed eligible. From quarter 2 to quarter 3, we see a more than doubling in the number of women eligible for benefits yet only a 56% increase in the number of women enrolled in a CMO. This indicates a delay in getting women to choose their CMO. These women were likely auto-assigned to a CMO after failing to make a choice. The CMOs reported a little over 39% of the enrolled women as active participants (received services) in the program.

The CMOs provided data on IPC enrollment separately from data on FP only enrollees. As of September 2011, all three CMOs reported having 2 IPC enrollees each. CMO3 reported that each of their 2 IPC enrollees had a care plan in place. Even though we saw a dramatic increase (180%) in the number of women eligible for IPC services from Q2 (5) to Q3 (14), these numbers are still very small and we only saw a negligible increase in the percentage of IPC eligible women actually enrolled in a CMO; this percentage went from 40% in Q2 to 43% in Q3.

The CMOs also reported on the number of employees they have hired to serve those eligible for the Resource Mother/Case Management benefit component of the waiver. In the table below we show these numbers along with the number of participants the CMOs reported as being served by their Resource Mothers.

As we noted above and in our earlier reports, there is a delay between determination of program eligibility and CMO enrollment due to the time needed for the woman to either choose her CMO from among the CMOs participating in her area or be auto-assigned. There have also been delays between the initial application and receipt of the finished application by the Right From the Start Medicaid (RSM) workers. We report on these delays in a later section of this quarterly report.

## EXPENDITURES

### *Administrative Expenditures*

Administrative expenditures under the Demonstration were incurred largely for the RSM case-workers, Policy Studies Incorporated (PSI) enrollment services, and DCH program staff. Because a separate administrative budget was not established by DCH for the Planning for Healthy Babies program, the program's administrative expenses are not included in this report.

### *Benefit Expenditures*

The total Federal dollars spent on FP Benefits for those enrolled in only the family planning component of the waiver in the third quarter totaled \$382,541, all of which was paid through the CMO capitated PMPM arrangement in Georgia's Medicaid program. A total of \$550 Federal dollars were spent on FP Benefits for those enrolled in the IPC component of the waiver in the third quarter, all of which was paid

through the CMO capitated PMPM arrangement in Georgia’s Medicaid program.

#### **UPDATED BUDGET NEUTRALITY**

DCH continues to utilize the revised budget neutrality worksheet sent by CMS in early September 2011 for budget neutrality reporting. Please see the attached draft worksheet updated with information for this third quarter report. We will edit and finalize the worksheet upon receipt of feedback from CMS regarding our approach.

#### **P4HB COMMUNICATION PLAN and OUTREACH ACTIVITIES**

The multi-pronged communications plan for P4HB continues to be followed. This plan incorporates five (5) specific phases for the marketing of P4HB throughout the state. Each of these phases is described in Table 2 below. Lyndolyn Campbell is the new project director for the P4HB program and has taken on the responsibility for monitoring the implementation of the various phases of the communications plan.

**Client Outreach**

DCH conducted extensive client outreach during the third Quarter of 2011. Specifically, Right from the Start Medicaid (RSM) workers from 17 different counties made over 400 presentations about the P4HB program to interested individuals in communities throughout the state of Georgia. P4HB client outreach activities ranged from health fairs, to radio public service announcements, to church meetings, and visits to children’s hospitals and youth development centers. RSM workers made one-on-one presentations as well as large-scale group information sessions. Attendance at most outreach activities was high, with several activities being attended by as many as 1,000 people. For example, in LaGrange, GA, RSM workers promoted P4HB at two events that were attended by 1,000 people (“Paint the Town Pink” party and “Troup Family Day”). A complete list of the P4HB outreach activities for the third Quarter can be found in the Appendix.

## **Provider Outreach**

There have been no new provider outreach activities during the third quarter. DCH is working with the CMOs to develop and implement a provider survey that will help inform the state as well as the CMOs about network providers' knowledge and understanding of the P4HB program and potential barriers that remain. The results of this survey can be used to guide future outreach efforts by both DCH and the CMOs to their provider networks.

## **P4HB Marketing**

Phase 3 of the Communications Plan details the Consumer-based Outreach activities for P4HB. A marketing budget was created to facilitate these outreach activities. During the third quarter, DCH continued to work with the second phase of this marketing budget, to widely disseminate information about the program and market it to potentially eligible women. We note that the Phase 1 marketing costs were expended by the start of the third quarter and that DCH expended all of its remaining marketing funds by the end of the third quarter. However, many of the marketing efforts will still be in evidence in the coming quarter as billboards and bus shelter signs that alert the general public to the existence of the program, will remain in place throughout the state.

The projected marketing costs for July 2011 through December 2011 totaled \$61,019 for contracts with "resident" marketing companies to produce advertisements about P4HB. Also in this phase, there was a total marketing cost of \$68,811.92 projected for pending contracts for additional advertising purchases. The total Phase 2 marketing costs were \$129,830.92. Of this amount, \$31,375 was estimated for PSA billboards in 10 counties which represent areas with the highest LBW rates (*Benn Hill, Crisp, Spalding, Dougherty, Bibb, Lowndes, Walker, Muscogee, Richard, and Tift*). Approximately 55 billboards were rented for a period of 6 months for the purpose of advertising P4HB. Blue Line Media was hired to provide bus ads for 3 months in the Savannah and Columbus markets with a minimum of 100 buses per

city. Total costs for these activities were \$7, 744. CBS Outdoor/Marta was paid \$21,900 to produce 275 interior bus cards, advertising on 15 bus shelters in the greater Atlanta area. In addition, \$690 was spent for printing costs of Spanish posters, and \$3,369 for printing Spanish postcards. Furthermore, \$1,690 was spent during Phase 2 for the shipping of Spanish postcards and posters. Radio One was paid \$31,500 in a new contract to run radio ads about P4HB for a 6-week time period. Finally \$1,400 was spent advertising the P4HB in the Expectant Mother's Guide, which will run the advertisement from August 2011 through January 2012. This Guide is available in Fulton, Dekalb, Gwinnett and Cobb Counties.

#### **BARRIERS TO ENROLLMENT**

The application approval process continued to serve as a barrier to enrollment in P4HB. Data obtained from DCH's tracking reports indicate that, while the average number of days varied widely during each quarter, the overall pattern was one of increasing average time (in days) from application to referral to RSM from January to September. In the 3<sup>rd</sup> quarter of 2011, the average time went up 58%, from 12.3 days on average in June to 19.5 days observed in July, and increased another 23% to 23.9 days in August. However, in September, the average number of days was back down to 15.0. For the year, then, the average number of days between application and referral increased from 12.5 to 15.0 days (20%). One source of this delay was that potential enrollees failed to submit the required documentation in order to assure that a timely approval process could take place. (Source – P4HB – Report 15, July-September 2011)

A second barrier appeared to be the Federal requirement that original documents be used for verification of citizenship. In light of this, DCH educated local public health offices that as a qualified Medicaid provider they could view original identity verification documents, copy and then indicate by

signing the copy, that the originals have been viewed. This signed copy could then be sent to PSI with the application. This action did not appear to have reduced the delays from application to referral since the average number of days between application and referral increased from 12.3 days in June to 15.0 days in September.

## **ACTION PLANS**

### **1) Auto Enrollment of Women Delivering on Medicaid (under RSM) Eligibility**

DCH is currently testing changes to its administrative structure so they can put into place a system to auto-enroll Medicaid eligible women, who delivered under the RSM eligibility criteria, into P4HB. Once the system is complete, RSM women will receive a letter, informing them about P4HB, the option they have to opt out of the program and informing them that they will stay in their same CMO unless they choose to opt out of it. This should expand knowledge of the program and increase enrollments as women will not need to submit a new application but will be considered a Continued Medicaid Determination. However, for those with a VLBW baby, the IPC form will need to be submitted.

**2) Maintain ongoing communication with family planning and OBGYN providers:** While DCH has worked with family planning and OBGYN providers to inform them about P4HB, this communication will continue throughout the life of the waiver program.

**3) Engage Providers Involved in High Risk Pregnancies:** Providers continue to be encouraged to increase their outreach to these women. Upcoming CMO surveys of providers (and clients) in the latter part of the year should provide more insight into barriers to enrollment. We anticipate further increases in the IPC enrollment in future Demonstration quarters.

**4) Engage Georgia's Title X Family Planning Program:** DCH continues to actively and regularly engage Georgia's Title X Family Planning Program. Lyndolyn Campbell, previous director of the Georgia Title X program, has joined the DCH staff as the Director of Women's Services and replacing Kaprice Welsh. Future communication regarding the P4HB program in Title X campaigns or other marketing efforts will be more closely coordinated with DCH activities regarding P4HB.

- 5) **Market P4HB in Areas/Programs where Low-Income Women Receive Services:** Teens or other young women who are uninsured and either paying out of pocket for family planning services/supplies or going without needed services are at high risk of an unintended pregnancy. DCH hopes to continue to market so as to reach these women in sites such as WIC or food stamp offices, farmer's markets or other sites where women gather and are able to receive brochures. Some of this effort is reflected in the local meetings held by RSM workers across the state during the third quarter.

### **EVALUATION ACTIVITIES**

The activities during this third quarter have included: 1) approval of the Evaluation Design by CMS; 2) discussions with DCH regarding the Data Sharing Agreement between DCH, Thomson Reuters, Inc, Emory University and Division of Public Health—all parties are awaiting its final approval; 3) working to refine the request for data from the Title X office; 4) merging poverty related data for populations by census tract onto 2009 linked birth/death records for piloting file construction; 5) beginning to develop code to measure the time between deliveries on Medicaid for the same women using data prior to the waiver; 6) finalizing survey instruments for the CMOs to use with their clients and providers (Attached) and 7) seeking funding for a fuller process evaluation.
